Article 5 of Chapter 12 of the 2003 City Code of the City of St. Francis, Kansas, is hereby established to read as follows:

ARTICLE 5. MUNICIPAL POOL 12-501. OVERALL MANAGE-MENT AND CONTROL. The mayor and city council shall exercise overall management and control over the St. Francis Municipal Pool and grounds and will make final decisions concerning operations, maintenance, improvements and per-

12-502. POOL BOARD. A pool board is hereby established to assist the city council in the day to day operations of the pool with its directive from the council being as fol-

(a) To provide direct oversight and assistance to pool employees as to normal operations and maintenance of the municipal pool and (b) To provide immediate super-

visory functions over the pool man-(c)To directly assist the city council by making recommendations as

to personnel and wages.

(d) To coordinate maintenance of ATTEST: the facilities, authorize and sched- /s/MARY P. LAMPE, City Clerk

council with capital spending recommendations.

(e) To serve as a direct contact with members of the public in areas of public relations, comments and concerns

(f) Establish user fees and adopt such public rules and regulations as the board deems appropriate to assist in the day to day use and operation of the municipal pool.

12-503. POOL BOARD MEM-BERSHIP. The pool board shall consist of at least five, but not more than nine, members appointed by the mayor with the consent and approval of the council who shall serve on an annual basis from February to February. The board shall consist of one council person, the city superintendent, with the rest of the members being at-large from the community. To the extent feasible, the at-large members shall be individuals who either utilize the pool or have family members who utilize

12-504. POOL BOARD MEET-INGS. The pool board shall meet at such time and places as its members deem appropriate. Meetings shall be open to the public.

12-505. REPORTS TO COUN-CIL. A member of the pool board shall provide the city council with monthly reports during the months of pool operations and present pool board recommendations for consideration and further action by the city council.


