Sheriff given permission to make emergency repairs

The sheriff told the Cheyenne County Commissioners at the Tuesday meeting that over the holiday weekend, the county was down to one working vehicle.

Sheriff Troy Gardner had called each of the commissioners when the transmission went out of the gold Blazer and they had said to get it fixed. Before the weekend was over, the fuel pump had quit working in the green Jimmy and he was able to get it fixed. However, the placement of the fuel pump made it more expensive (around \$750) to replace and he had gone over the \$500 limit spent without asking the commissioners for permission.

The commissioners assured Sheriff Gardner that they understood and it was a emergency situation—The county needed that vehicle back into working condition as quickly as possible.

All the repair expenses posed another problem as Sheriff Gardner said there was not enough money in his Commodities Fund. The com-

missioners and sheriff talked about which fund to take the needed money from, noting that there would be a negative amount in that line item. He said they had sufficient money in Capital Outlay and Personnel but the commissioners recommended that the expenses be taken out of Capital Outlay. They will talk to the auditor and see what he recommends.

Sheriff Gardner recommended that Bob Juleson, deputy, be raised to Level Two on the pay scale. He has been with the county for the required three months and had met all the expectations of the job. The commissioners agreed because the sheriff's budget could handle the increase.

The sheriff and the commissioners went into executive session for 10 minutes to discuss personnel. No decision was made.

Ambulance department

Larry Gabel, emergency medical service director; and Janelle Bowers, ambulance department bookkeeper, had the contractual write-

offs in the amount of \$4,300. The commissioners agreed to allow the write-offs.

The director presented his monthly budget. Commissioner Jane Brubaker asked why the phone bill was so high. He said it was because of the new phones they had purchased. The commissioners said new phones used for the ambulance service could be paid for with 911 Funds. Clerk Terry Miller said he would make the adjustments. Later, it was reported that the phones were not represented on the bill and had already been paid for using 911 Funds.

Commissioner Andy Beikman asked about re-supplying the ambulance — that it appeared there were a lot of new supplies. Mr. Gabel said many of the supplies were outdated and needed to be replaced.

The director and commissioners then turned to the collection of delinquent bills of those who had used the ambulance and either insurance or Medicare/Medicaid had not paid



about ways of collecting the money including putting a lien on their state income taxes. Mr. Beikman said he hated to see the commissioners bent on getting a person's last dime. Mrs. Brubaker also pointed out there are those who will abuse the system.

The commissioners agreed to have county attorney Justin Barrett review these bills and determine if a settlement can be reached and at what percentage of the bill would be acceptable. There were three bills, one which had gone back to 1999, which the commissioners wrote off.

Motor Vehicle Fund

County treasurer Dolores Jenik said that some treasurers are misusing the Motor Vehicle Fund (the name has been Treasurer's Special Fund). She said that some commissioners are not aware of the fund. This was not the case of the Cheyenne County Commissioners as the money left at the end of the year is transferred into the county's General Fund.

The fund was set up many years ago when the treasurer's offices were contracted for renewal and title work for vehicles. In a year, Chevenne County collects around \$20,000. The money is used to buy paper products, pay dues and costs of meetings.

Last year, between \$13,000 and \$18,000 was transferred into the county's General Fund.

Mrs. Jenik said she will be making quarterly budgets and will bring them to the commissioners' for their approval. She indicated that the reason for the commissioners' approval was to make program. In the past, the county sure they were aware of this money and how it is being spent.

Road and bridge
