School board shown the state website

Members of the Cheylin Board of Education were given a walk-through of the Kansas Department of Education's web site during Monday night's meeting.

Anita Burton, school counselor, presented the Adequate Yearly Progress Report, on the Cheylin schools, with the help of several of the school's lap-top computers. The school information can be located at www.ksbe.org>www.ksbe.org.

Mrs. Burton reported that students at Cheylin scored well above average in both reading and math. She stressed the importance of academic standards when it comes to state assessment tests because the test scores must improve each year.

Discussion quickly turned to the high expectations of the state after Mrs. Burton reported that a brand new test will be given this spring to students in third through eighth grade and one class in high school.

"I don't want us to be teaching tests," said Rod Young, board member.

"It gets to the point where teachers are teaching items that they perceive will be on the tests," said Dave Zumbahlen, superintendent. "Unfortunately, our accredidation depends on how well we do on the state assessments."

He said the would guess most students spend approximately three weeks of each school year taking tests.

"I think we're doing what we need to do," added Mrs. Burton. "It's hard during the first year (of new test). We're working on the standards, that's what the tests will cover."

Enrollment fees

During open forum of the meeting, a parent discussed concerns about enrollment fees. She referred to an education statue which allows the board to waive enrollment fees for families facing hardships who are unable to afford them.

percentage of students at Cheylin qualify for the National Free/Reduced Lunch Program, they would be waiving enrollment fees for a majority of the students.

The parent suggested that because the Kansas Department of Social and Rehabilitation Services upholds strict guidelines for assistance, perhaps the board should focus on families receiving support from them, such as food stamps.

Each year, the Kansas Department of Social and Rehabilitation Services sends schools a list/electronic file of students receiving food assistance/ benefits. The list/electronic file includes children age 5 years or older who live in the county served by the school. Schools use this list to provide benefits, such as free lunches, to the eligible students.

This list/electronic file may be a helpful tool for the school to use to determine eligibility for the enrollment fee waiver.


After brief discussion, members of the board decided to add the issue to the December agenda.

A Cheylin student has requested permission from the board to participate in the wrestling program offered at St. Francis Community High School. A cooperative agreement has been offered which, if signed by all parties, including the Cheylin Board of Education, would allow the student to participate and to attend practices and tournaments with the St. Francis team.



Board feeds workers

The Cheylin School Board



Statute 72-5391 reads that "whenever the parents or guardian of any pupil of the school district are unable to provide the fees and supplemental charges assessed and collected under authority of subsection (a) of K.S.A. 72-5390, the board of education shall, if written application is made and said board finds the application meritorious, waive said fees and supplemental charges if the items for which said fees and supplemental charges are assessed and collected are necessary for the completion of the basic requirements of courses of study offered in the school district."

She said that she feels that an application should be made available to families who may qualify.

"My question is," she said, "how can a parent request a waiver (of the fees) if they don't know the option exists?"

She requested that the board consider creating a specific waiver policy, including an application, eligibility requirements and appeal procedure and including the policy in future student handbooks. She also requested that a waiver application be available to parents during enrollment, so they are aware of the policy at that time.

Mr. Zumbahlen asked the board what criteria would determine eligibility, and how would the board determine which application is "meritorious.'

The parent replied that other schools in the state base eligibility requirements according to their free/ reduced lunch status.

"I have a huge problem with using free lunch as a guide," said Kerby Krien, board member.

Other members of the board agreed with Mr. Krien. Because such a high able mention running back.
