## **Restaurant has new owners;** still serving the same steaks

By Casey McCormick Big Ed's Steakhouse in Bird City is continuing its tradition of bringing some of the best steaks in the state to its tables. However, the operation is being carried on by new owners, Robert and Sherry Cherry.

"It has a pretty neat history," Mr. Cherry said, "but it is still Big Ed's Steakhouse.

Big Ed's started 21 years ago when Ed Thomas purchased the building and began serving steaks in what was an old pool hall. The next owner was Richard Upchurch, who continued to improve Big Ed's for the last 14 years.

Mr. Cherry first came to this area in the mid 1990s to hunt and discovered the landmark restaurant. Both Mr. and Mrs. Cherry are avid hunters and they kept making trips to northwest Kansas and southwest Nebraska.
