
Earning Superior I ratings for their Vocal Solos were Kaedra Dixson and Nikki Johnson



The St. Francis Livestock Commission had one of the larger sales on April 4. However, this sale not only sold cattle to buyers but one yearling heifer was sold over and over again.

Donated by Skip and Betty Petersen, along with their children, Robin and Brett and grandson Preston, the heifer brought \$740 the first time, going to the high bidder. Then the bidding began again and each time it stopped, the buyer donated his bid to help Bird City families who lost almost everything in the tornado which hit the area on March 28. When the last bidder raised his hand and some after-thesale donations were made, the total was nearly \$8,500.

The Petersens, who own Western Auction and Real Estate, once owned the sale barn. They knew these families and wanted to help.

"We wanted to support the entire community and we saw a need," Mrs. Petersen said.

The money will be donated to the Nick Ketzner, Lynn Glasco and John Kamla families.

#### **Big sale**

Loyd Wilson, owner of the sale barn, said the April 4 sale was a big sale with about 1,300 head. He had combined the cow/calf sale with the feeder cattle sale which put the numbers up.

The sale totaled nearly \$1 million.

"The cattle really sold well with a lot going out of the state," Mr. Wilson said. "There is a lot of interest in the sales."

The cow/calf pairs sold well, going anywhere between \$1,500 and \$1.550.

He said he was impressed at the total brought in for the tornado victims, noting that there have been several such fund raiser in both St. Francis and sale barns he is affiliated with in Nebraska.

"It's neat how people step up and help out," he said.
