Board hears programplan on wrestling

Monday evening's school board meeting heard athletic director Max Keltz and assistant volleyball coach Kendall Cahoj approach the board with a proposal to begin a wrestling program in the Cheylin High School. When the discussion ended, the board voted "no" 3-4.

"I don't think this will hurt the basketball program, I think it will help it," Mr. Keltz said.

He went on to explain that he had a number of interested kids and that only one of them would probably go out for basketball. He included that the school had a good number of boys enrolled and would have for a number of years into the future.

"This would be an opportunity for some kids to improve themselves in a way not available to them right now," Mr. Keltz said

Expense estimates for mats were approximately \$6,000 for new ones, and uniforms about \$100 per kid to include singlets and sweats. The idea of using track sweats was one way to defray start up costs, as well as shopping for used mats.

At the Thursday meeting, the board discussed dates prior and after the proposed date but there were so many conflicts that they decided to leave it as it had been for the last few years.

Dave Flemming was present after being asked by Mr. Cooper about what options there were for repairing and maintaining the road leading to the fair building. There is about 1,100 feet of road.

Mr. Flemming brought four different options he had researched. The first would be concerning grants or tax credits if the board come in and it would cost approxi- should be present at the meeting to mately \$22,000.

The second option would be for the county to purchase, haul and lay hot-mix aspahlt at \$50 a ton, costing \$15,000.

The third option would be the county purchase asphalt millings from the state and, in the spring, use Reclamite, a substance which breaks down the asphalt pieces, would need to be added. The cost for reclamite is \$3,000.

The most economic would be to get the asphalt waste at no cost from the city at the recycling center and add the Reclomite at \$3,000 plus there would be a chip seal costing

The road would then need sealer every four to five years. With only about \$2,000 in the

bank, the board is limited on what they can do.

Mr. Cooper and Mr. Flemming had talked to commissioner Andy Beikman. It was their understanding that the fairground road would be on the agenda for the commissioners to see if they could help with some of the expense. Mr. Bursch would have to have a contractor said he felt some of the members answer any questions the commis sioners may have.

Mr. Cooper said the fair building is a main building where community functions are held and it would be nice to have a decent entrance

Ice cream stand

Mr. Bursch had been approached by a member of the Christian Church about building an ice cream stand. The group would like to put a permanent building beside the Methodist Church Funnel Cake stand.

The board did not have a problem with them putting up a building, however the group would have to bring in plans before any construction started. The board also said that the expenses of getting electricity to the building would be the church's

responsibility. Office building

Mr. Cooper and Clay Zimbelman, member, have found a 10- by 16-foot building that needs some repairs but could be used as an office building at the fairgrounds.


