## Obituary

### Emma E. Aguinaldo

July 10, 1911 - Dec. 12, 2007

Emma Evelyn Aguinaldo died Wednesday, Dec. 12, 2007, at Cridersville, Ohio, at the age of 96. She was born July 10, 1911, at Atwood, Kan., the daughter of the late Clayton Albert and Mamie Ruth (Egelston) Martin.

Emma grew up at McDonald, where she graduated from McDonald High School in 1931.

She began teaching in a one-room school house for several years to earn money to go to college. One of her duties in the early years was to come to school early and start the stove and warm the building in winter before the students arrived.

She was courageous as she traveled by herself on a long sea voyage to the Philippines where she married Richard Aguinaldo on June 12, 1938. When World War

II broke out she had to leave their home while he remained to fight. She had no contact with him for two years after he was captured, but told everyone that she would know if he were not coming home and she never lost her faith that he would return to her, which he did.

Emma continued her education and received her bachelor of arts degree from college at Greeley, Colo., and her master's degree from the University of Kentucky at Richmond.

Richard and Emma came to Lebanon, Neb., in 1960. Emma taught school in several communities and also privately taught piano and organ to many students.

She was the church organist at the Lebanon Presbyterian Church for many years and also served as the city major of Lebanon.

Emma was preceded in death by her husband, Richard; three sis-

ters, Hazel Clayton Schuyler and her husband, Dean; Lillie Carleton and her husband, Walt and an infant sister, Rachel Martin.

Emma is survived by nieces, Cheryl White and husband, William of Frederick, Md., Connie Nelson and husband, Robert of Lima, Ohio; Carla Carleton of East Lansing, Mich.; Cynthia S. Cooke and husband, William of Earlysville, Va., and nephews, Randall I. Schuyler and wife, LaVerne of Lancaster, Va., Gregory C. Schuyler and wife, Connie of Ballston Lake, N. Y., and Spencer H. Schuyler and wife, Yulia of Greenbackville, Va.

Visitation is Thursday, Jan. 10, at Herrmann Funeral Home in McCook and a grave side interment will be held on Friday, Jan. 11, at 1:30 p.m. in the Lebanon Cemetery with Keith Theobald officiating.

# Annual coyote contest draws 130 hunters to area

scmcormick@nwkansascity.com The 2008 Midwest Coyote Calling Event was held over the weekend and brought in many hunters, camera crews and sponsors as well as people coming just to see the action.

From Friday through Sunday, the hunters traveled from several states to join locals for the hunt. Participants reported 943 coyotes spotted which is around 200 more than last year. There were 293 brought back to St. Francis.

Two of the coyotes brought in weighed over 40 pounds. The team of Schmid-Schmid had one at 46.6 pounds and Liposky-Tiemeyer had a 44.2 pound coyote. The average number of coyotes brought in by each team was 3.44, Predator Sniper class; and 2.42, Sportsman Warehouse.

There were 75 Predator Sniper teams and 55 Sportsman Warehouse teams which totaled 130.

Brent Rueb, St. Francis, has organized this event for 11 years.

"Everything went very smooth again this year," Mr. Rueb said, "and we had an excellent turnout."

Over \$34,000 in money and prizes were given out.

The first place winner in the Predator Sniper (formerly Predator Xtreme) Class was the Liposky-Tiemeyer team from Fairfield, Neb. The Leighton-Mayer team from Scott City took first in the Sportsman Warehouse Class.

Rodney Radcliff, St. Francis, was named as the "Sportsman of the Year."

National magazines were present and will have articles about the contest and there were also filming crews present. The event attracted a variety of people to the area.

"The St. Francis contest is the largest two-day event in the country," Mr. Rueb said.

This year the number of teams was increased to make the event even bigger.

Travis Hilt, Kansas City, was one of the callers who traveled to participate for the fourth straight year.

"It was better than ever," Mr. Hilt said, "More teams made for a better contest."

"The event was well organized."

When the hunters returned Sun-

day afternoon a large crowd gathered at the Cheyenne County Fairgrounds to watch the coyotes get weighed and lined up.

"We had many favorable comments on the contest," Mr. Rueb said. "The hunters liked the professionalism on how the contest was run as well as complementing on the facility and the trophies which were made by Reed Raile."

"The community came out and supported the event as well as there were many national sponsors."

About 80 more coyotes were brought in this year than last year. Snow from previous storms made it easier to spot the animals.

Results: Predator Sniper Class: Liposky-Tiemeyer (Fairfield, Neb), 11 coyotes, first place; Edis-Lovitt (Mullen, Neb), 11 coyotes, second place; Hughes-Johnson (Colorado Springs-Edgar, Neb) 10, third place.

Sportsman Warehouse Class: Leighton-Mayer (Scott City) six, first place; Roane-Roane (Goodland) five, second place; Scofield-Yancey (Florence, Colo-COlorado Springs, Colo) three, third place.
