

The director of the physical therapy department reported at the Cheyenne County Hospital Board meeting on Thursday.

Shara Johnson, physical therapist, is the director of the physical therapy department. Board has several decisions to make

Finding money to proceed with projects was discussed at length when the Cheyenne County Hospital Board met on Thursday. In the end, the board agreed to stay on track with the original plans to complete the projects.

For months, the board has been talking about finishing the labor/delivery room project and remodeling the kitchen.

The kitchen will not pass the Kansas Department of Health and Environment inspection again. The administrator and architect were working on the kitchen project when an inspector arrived. Since there was obviously work underway, the inspector gave the project some time to be completed. The cost of the kitchen remodeling had originally been projected at \$140,000.

The obstetrics labor and delivery room had come in way over the \$40,000 projected budget. Room five in the hospital has been designated for babies and their mothers. The room has worked but is far from what was planned.

Les Lacy, hospital administrator, had two options prepared for the board at the Thursday meeting. He said that he was the mediator and, the end decision would be up to the board but, at least they would have two options from which to choose.

The first option was to go with the original plan to remodel two rooms and delivery room and the cost would be around \$180,000. The kitchen would also be remodeled, possibly taking space out of one of the existing basement rooms to enlarge the dining area and the cost would be around \$200,000.

Mr. Lacy and Shawna Blanka, administrative assistant, had measured off an area south of the nurses' station in hopes of building


