911 Dispatch **Board main** topic again

karen.k@nwkansas.com The 911 Dispatch Board was again on the agenda when the Cheyenne County Commissioners met on Tuesday, April 15. The date of Thursday, April 17, was set for the first meeting of the board.

Carol Gamblin, dispatch supervisor, presented a call count report for the office. The dispatch communication board was discussed. After talking to the trainer/auditor for the Kansas Highway Patrol, Chairman Andy Beikman had reported at a previous meeting that a board of five with three sub-committee members was recommended. The three sub-committee members were to be the highest law officers.

Appointed to the dispatch board were: George Harper, St. Francis fire chief; Jannelle Bowers, emergency medical service director; Gary Rogers, emergency manager; Mr. Beikman, county commissioner; and Natalie Knodel, St. Francis City Council. Appointed to the sub committee were Deborah Farland, St. Francis Chief of Police, Craig Van Allen, sheriff; and Justin Barrett, county attorney.

Because of the position and a matter of confidentially, all committee members were required to fill out a form. Mr. Biekman reported that Chief Farland had removed her name and put in the name of Jim Walters, a city police officer. A background check was also made on all board members.

The board met on Thursday. They will meet again on May 1. Legal council will also be present to help establish some guidelines.

Mrs. Gamblin asked for five minutes of executive session so she could discuss personnel. No decisions would be made.

Mr. Flemming said he had discussed the matter with the department's official. The official said when the correction had been made, he was to take photos and send them to the department.

Fair board report

Dick Bursch, county fair board president, had an agreement between the fair board and the Christian Church. This agreement is for the ice cream parlor the church will be erecting at the fairgrounds. The agreement was signed.

Mr. Bursch discussed the land swap between Butch Ewing and the county. The county attorney will create the deed for the swap.

Sheriff's report

Sheriff Craig Van Allen asked for 10 minutes of executive session to discuss personnel. Upon return to regular session, it was announced no decisions had been made.

On April 5, Keltz, Walden, and Mitchell Jensen were the first place team in the division with Keltz placing first, Walden third, and Jensen fourth highest.

The Cheylin teams attended the Northwest District livestock judging in Hays on April 14, and scheduled to host livestock judging on April 28.

The contest season will conclude with the state contest May 4 through May 6.

On Wednesday, April 15, the Cheylin junior high track meet was held in St. Francis. There were 11 tough teams competing.

Bowers presented write-offs in the amount of \$1,735.

Chairman Beikman said he had been approached by a citizen wondering what a base ambulance run cost. Mrs. Bowers said the runs were comparable to other counties. She said there are different charges for different runs. Some of the runs include motor vehicle accident, local and airport runs. She also noted that the runs cost included the ambulance supplies.

"Insurance seldom covers all ambulance costs," she said.

Sheriff Van Allen asked that officer, Jonathan Lanz, be moved to Level II now that he has completed training. This was approved.

The sheriff said he would be needing about \$2,000 worth of ammunition for training purposes. The commissioners agreed, but told Sheriff Van Allen to make sure he received bids for the ammunition. in the commissioners' room in the courthouse.
