She enjoyed doing art design for screen-printing. She also helped her mom, Shalah, with web design and marketing Shalah's artwork. Natalie was very good on the computer and enjoyed working with it.

Natalie was a past member of the Wesleyan Church, Bird City, a member of the Kenton United Methodist Church, Kenton, Okla, where she taught Sunday School, Vacation Bible School, and was the church treasurer for a number of years. Natalie was also a member of the Campo Park and Recreation Board, and the Campo

Watermelon Festival, where she did the scavenger hunts and was treasurer for both and a member of the Campo Booster Club.

While living in McDonald, Natalie was involved in a Hobby Club. She loved taking part in the Kenton Easter Pageant; she was the leader of the mob for many years. This year was the first year, due to Natalie's illness, that she couldn't help. Natalie was also involved in the Emmaus and the Kairos Prison Ministry's.
