## Council approves payment for pool expenses

The Bird City Council quorum was met for the September meeting; however, at the request of Councilwoman Deb Smith the approval of the August meeting minutes were tabled until next month because Councilman Frank Serrano was the only member from the last meeting to at-

tend the present meeting. **Pool expenses** 

Mayor Troy Burr read a letter from Cheylin Recreation Commission requesting \$673.96, the expenses for the pool, paint and supplies used. This request was based on an agreement between the city and the commission to share expenses. The commission wrote that they had agreed not to charge the city for half the labor expense, which was part of the agreement.

Tabetha Ketzner, city clerk,

asked where the payment would come from because the pool fund was over budgeted. Mayor Burr said that payment would be from the city general funds.

Craig White, city maintenance, asked about the labor agreement the city had with the Commission. The reason was that city maintenance had spent a few days working on the pool.

Mayor Burr said that taxpayers' money goes to the Recreation Commission and the agreement was the city would do structural repair and provide water at no cost to the Commission. The city and Commission jointly share the supplies, replacement of filter and heater, winterizing the pool and jointly obtain liability insurance.

Mr. White said that he just did not thoroughly understand the labor agreement. Mayor

Burr said that the city was able to do the work and should without keeping track of hours. Councilwoman Smith said that the city was probably getting the better end of the deal. The approved to pay the bill.

Terrorist insurance

The council discussed the payment of the annual Traveler's Insurance of \$12,851 to Wright Insurance Company. This raised the coverage by \$75,000 and dropped the premium by \$133.

The coverage included the \$89 premium for terrorist insurance but, did the council want to continue with the coverage. While Bird City may not be a terrorist target, Mayor Burr mentioned that a terrorist act could include the city's water system. They approved to pay the insurance.

Building permits

Two building permits were approved by the council. Darlene Burr for remodeling family residence by putting up an awning over the backyard porch. Canda Orten, approved to remodel existing structure by putting in a driveway and sidewalk.

Tree contamination

The recent concern of over spraying tree with herbicides was addressed at the meeting. County Extension agent, Joe Leibbrandt, responded to a request by the city to answer a concern by Councilman Serrano of the possibility of over spray by city maintenance.

Mr. Leibbrandt reported from his findings that the damage done to the local trees was caused largely by hot and dry weather such as leaf scorch. In addition, ironchorsis due to iron deficiencies and witch broom were identified as problems.

The council tabled a payment request from Miller and Associates for contracted worked done on the waste water lagoon for the month of August until Chris Miller, owner of Miller and Associates, attends a council meeting and brings the members up-to-date on the construction progress.

Council purchases

The council approved purchase of a Rhino 1540 hydraulic blade for moving snow and dirt from Ken Gerdes for \$2,500 with a \$1,000 trade-in for the old blade. In addition, \$10,000 was approved to purchase gravel for city streets, size of gravel to be at Craig White's discretion.
