
"We made some plays when we

"Included in the requirements are retail muscle cuts such as beef and pork roasts and steaks. Ground beef, lamb, chicken, goat and pork; and perishable agricultural commodities such as fresh and frozen fruits and vegetables are also included, as are peanuts, pecans, macadamia nuts and ginseng," Ms. Blakeslee said.

Fish and shellfish also are subject to the country-of-origin labeling rules, and they're required to 3171.

New food labels on familiar specify production methods (wild

Excluded from the labeling rule are processed foods that have undergone a physical or chemical change (such as cooking, smoking "The new labels are an out- or curing) or have been combined or components (such as breading or tomato sauce). Also exempt are restaurants, cafeterias, food stands and bars that serve food.

> "Country-of-origin labeling rules will become mandatory March 16," said Ms. Blakeslee, who spends working hours answering food and food safety questions as coordinator of K-State's Rapid Response Center.


