Cervical cancer was once the tested in the past five years.

> More African-American and Hispanic women get cervical cancer and are diagnosed at later stages of the disease than women of other races or ethnicities, possibly because of decreased access to Pap testing or follow-up treatment. It is important for women of all races and ethnicities to seek early detection and treatment. In Kansas, African-American women die of cervical cancer at a rate twice that of white women.

> In addition to screening tests, a vaccine is available which can prevent cervical cancer. The vaccine targets the human papillomavirus (HPV), which is present in more than 99 percent of cervical cancer cases. The vaccine is recommended for girls to help prevent cervical cancer later in life. Parents are encouraged to talk with their daughter's health care provider for more information regarding the vaccine or contact the County Health Department.

The Kansas Department of Health and Environment through the County Health Office promotes cervical cancer for all women. 


