I believe every American citizen should attend at least one military funeral in their life, just one. If you did, you would never, never say one derogatory statement about our military men and women, or anything about their commitment to the security of our country ever again. You may not support the fighting that is going on around this world, but war is inevitable because of the nature of man. Moreover, since the written history of humankind, about 6,000 years, there has been recorded only 200 years of peace. And if I have said once, I have said it at least three other times — I believe it is the pursuit of happiness that everyone thinks they are entitled to that causes conflict, even at the expense of others. I don't want to get off track here, just wanted to lay some groundwork for you to understand why I think going to a military funeral is important to attend. My husband and I recently went to a military funeral, my first. Everything was going just as other funerals I have attended; however,

when the procession approached the cemetery, it was different from anything I had ever seen before. I believe I counted 10 military personnel in full dress standing at attention around the grave site. When the coffin was in its final place, the soldiers gave a gun salute and marched silently, in formation, around the coffin and after the final words honoring this veteran were said from the clergy, the ceremony began. With three soldiers on each side, they began to fold the American flag draped over the coffin. In unison, without a word, in silent respect, they folded the flag, unfolded, then folded again. The folded flag was taken by one of the soldiers and passed to another soldier with a final salute, who, in turn, passed it to a family member on bended knee. It was quite emotional and somewhere here "Taps" was played. Yep, I am quite sure that if everyone had to attend a military funeral, they would never, never be able say anything derogatory against our military men and women or their service to secure our country.
