Bakery shop opens in St. Francis

The products are baked on a farm located north of Goodland in Sherman County. The employees are handicapped and after learning baking skills, they can find work elsewhere. Supervisors insure what is made is of the highest quality.

"The bakery is a fully licensed food production location," Mr. Toler said. "We are the pilot store for these baked goods.³


