Farmers gather for wheat plot tour

About 45 farmers gathered at the K-State wheat plot tour on the Sunny Crest Farm south of Wheeler Wednesday afternoon. Off and on throughout the field day, light rain fell and it was chilly — most people had jackets on.

It appeared that the general consensus was the test plot looked good. Jeanne Falk, K-State multi-county agronomist, had planted 21 varieties, then strips of wheat with seed treatments and treated other plots with foliar fungicide treatments.

Brian Olson, K-State northwest area agronomist, and Erick DeWolf, K-State wheat pathologist, talked about the varieties planted, giving a short history of each type of seed, along with its strengths and weaknesses to environmental conditions and diseases. Varieties planted included: Overley, Jagger, Fuller, Jagalene, PostRock, Keota, Santa Fe, Hatcher, Ripper, Bill Brown, Turkey Red, TAM 111, TAM 112, T-81, T-140, Hawken, Smoky Hill, Winterhawk, Armour, Aspen and Danby. An interesting addition to the plots this year was the variety Turkey Red.

This variety came to the United States with Russian immigrants and revolutionized wheat production in Kansas. Ms. Falk said she included this older variety to show the advances in wheat breeding with semi-dwarf varieties that can stand better.

The two white wheat varieties planted were Aspen and Danby. Mr. Olson asked if there were any farmers present who had planted white wheat this year. None of them had and only a couple had planted white wheat the year before. Many had not continued to plant white wheat because of lack of available market and sprouting potential.

Mr. Olson, at the end of the test plot tour, said his recommendation for varieties to be planted in the county were either of the TAMs, the Colorado State varieties (Hatcher, Ripper, Bill Brown) specifically Bill Brown; and PostRock or Fuller.

They also talked about green bugs feeding in the wheat. Right now, there are lady beetles and lady bug larva found on the leaves and Ms. Falk said to not destroy them.

"Lady bugs eat greenbugs," she said. "They are good to have around."

The seed treatment study showed Fuller seeds planted in three strips. One had no treatment; one had Dividend Extreme; and the other had JumpStart.

Dividend Extreme is a fungicide seed treatment that provides control of several diseases. These diseases include loose smut and some root and crown rot.

JumpStart is a seed treatment that K-State is looking at, in several county wheat plots. Literature on this product says it is a phosphate fertility management tool that provides crops with better access to soil and fertilizer phosphate. This is the first year that K-State is researching this product to see if it increases wheat yields.

Farmers were urged to stop by the plot to see the difference as the wheat matures. Ms. Falk said she will have the yield results available as soon as wheat is harvested.

Dan O'Brien, K-State extension agricultural economist, talked about the markets, noting that in August 2008, the wheat market was \$9.50 to \$10 a bushel. However, today, it is right around \$6.50 per bushel. With weather delays and poor wheat in other areas, this year might be a good opportunity for Cheyenne County farmers, he said.

Following the meeting at the test plots, everyone went to Goodland Greenline in Wheeler where they enjoyed supper provided by the county grain dealers.

When the wheat test plot is harvested, the results of yields will be printed in *The Saint Francis Herald* and *Bird City Times*.
