

Other countries, including Mexico and Canada, have reported people sick with this new virus. This virus is spreading from person-to-person, probably in much the same way that regular seasonal influenza vi-

ruses spread. The Kansas Department of Health and Environment is continuing to work with local health departments and other healthcare providers to identify cases in Kansas and interrupt the chain of virus transmission wherever it is found. As of Friday, July 17, there have been 186 cases in Kansas confirmed with more testing taking place.



This program will provide livestock producers with a vital safety net to help them overcome the damaging financial impact of natural disasters," Mr. Vilsack said.

The Livestock Indemnity Program provides assistance to producers for livestock deaths that result from disaster. Using funds from the Agricultural Disaster Relief Trust Fund, The program is administered by the Department of Agriculture's Farm Service Agency. The Livestock program compensates livestock owners and contract growers for livestock death losses in excess of normal mortality due to adverse weather, including losses due to hurricanes, floods, blizzards, disease, wildfires, extreme heat and extreme cold. Eligible losses must have occurred on or after Jan. 1, 2008, and before Oct. 1, 2011.

The following table provides the final dates to file a notice of loss and/or application for payment for either 2008 or 2009 livestock losses.

Date of Livestock Death; Final Date to File a Notice of Loss; Final Date to Submit an Application for Payment.

Calendar Year 2008: (dates are in 2009 except for ones listed 2010) Sept. 13,; Sept. 13; Jan. 1 to July 12; Sept. 13, to Jan. 30, 2010; July 13, to Dec. 31; 30 days after death is apparent; Jan. 30, 2010.


