

\$10,000 donation received at hospital

karen.k@nwkansas.com The board treasurer told the Chevenne County Hospital Board on Thursday that a \$10,000 donation had been received.

Treasurer, Traci Neitzel, had a list of donations given to the board's memorial account, noting that Mildred "Micky" Lampe estate had left \$10,000. Mrs. Lampe, a resident of St. Francis, died July 23

The memorial money is used for special projects. In the past month, Mrs. Neitzel said there had been several donations of over \$4,000 and there were small donations, all adding up to \$11,200, not counting Mrs. Lampe's donation.

Hospital upgrades

Considerable time was spent discussing hospital upgrades. A new kitchen is needed. The board discussed several other needs including a patient-friendly entrance, increased outpatient/procedure rooms, imaging upgrades and labor, delivery and nurserv

In prior discussions with Kent Carmichael, architect, as a part of the strategic Facility Improvement Plan, it was learned that these improvements will not fit in the "footprint" of the present hospital building.

Mr. Lacy had drawn up three ways the board could finance a project and all were revenue bond options that are paid as hospital operating expenses. No concrete estimates of cost were available and Mr. Lacy was quick to point out that an extensive proforma would be necessary before any action could be recom-

necessary steps that would create expense, they would give the board enough information to commit to the project

Statistics and financials

The administrator went through the statistics and financials. He noted that the trend at both clinics was to show an increase of patients. In March, the St. Francis clinic had shown 642 patients and there were 620 patients in April but it had leveled off to 528 in July. All but July 2008 had over 500 patients.

In the Bird City Clinic, averaged 89 patients per month during the last year. In July, the number had gone to 112.

CAT scans and ultrasound were up. MRIs were also strong.

In 2009, there have been 15 babies born at the hospital. The staff is planning for 26 babies this year. Accounts Receivable at the hospi-

tal was \$1,289,941. He said the hospital has continued to have higher volume. Accounts receivable at the clinics was \$108,423 and, this figure, Mr. Lacy said, is stable.

The funded depreciation account totals \$1,348,213. Earlier, there was money drawn from this account, but, Mr. Lacy said, it was paid back with the cost report settlement.

Administrator's report

Administrator Lacy, in his report, said Tenille Lee recently attended a "mock survey" training course presented by Mary Kabriel in conjunction with Kansas Hospital Association and The Kansas health Education and Research Foundation. She

Lacy Reed, treasurer, reported the balance in the account at the present with all bills paid or checks written, is \$7,055.59. In addition, there were payment requests from Candi Douthit for \$459 and \$1,750 from Custom Trophy and Engraving
