AN ORDINANCE RELATING TO OPEN BURNING WITHIN THE CITY LIMITS, PROHIBITING THE SAME AND PRO-VIDING FOR CERTAIN EXMEPTIONS THERETO; AND AMENDING SECTIONS 5-201, 5-202 AND 5-303 OF CHAPTER 5, ARTICLE 2 OF THE CITY CODE OF THE CITY OF BIRD CITY, KANSAS AND REPEALING THE ORIGINAL SECTIONS 5-201, 5-202 AND 5-203 OF CHAPTER 5, ARTICLE 2 OF THE CITY CODE OF THE CITY OF BIRD CITY, KANSAS AND OR-DINANCE 277 WHICH AMENDED THE

BE IT ORDAINED BY THE GOVERN-ING BODY OF THE CITY OF BIRD CITY,

Section 1: Sections 5-201, 5-202 and 5-203 of Article 2 of Chapter 5 of the Code of the City of Bird City are hereby amended to read as follows:

5-201. OPEN BURNING UNLAW-FUL: DEFINITION: REFUSE. It shall be unlawful for any person or entity to cause or permit the open burning of any refuse, wastes, structures, vegetation or any other material on any premises within the City of Bird City, Kansas, other than in an approved incinerator constructed and operated in accordance with Air Pollution Emission Control Regulations of the State of Kansas and any amendments thereto as published by the Kansas State Department of Health and Environment or its successors. "Refuse" is defined as unwanted or discarded material resulting from residential, commercial, industrial and agricultural operations and from normal community activities. "Refuse" includes but is not limited to: garbage, paper, rubbish, dead animals, animal wastes, leaves, limbs and other plant wastes.

5-202. ALLOWED OPEN BURNING; REGULATIONS FOR THE SAME. The following open burning operations shall be exempt from the prohibition on open burning of any materials imposed by section 5-201, subject to the regulations set forth

a. The following shall not constitute a violation of this article.

1) Fires set for the purpose of instructing and training city firemen in the methods of fighting fire.

2) Fires set at the direction of the mayor or governing body for the destruction of abandoned and condemned structures and buildings

3) Fires set in residential fireplaces. 4) Fires used for preparation of food,

such as barbecuing or charcoaling; 5) Campfires in approved camping ar-

eas: Provided, that the fire is not more than four feet (4') in diameter at the base.

6) Recreational fires contained in a screened fire pit or screened outdoor fireplace. For purposes of this provision, "fire pit" means a self contained unit made of a non-combustible material which sets bove the ground on legs and is commercially designed and built for the creating and maintaining of a fire by use of a wood or gas fuel source. For purposes of this provision, "outdoor fireplace" means a commercially designed and built outdoor fire place made of a non-combustible material or concrete, including but not limited to a chiminea. For purposes of the provision, "screened" means a protective spark arresting screen covering the opening of the fire pit or outdoor fire place.

7) After obtaining a permit pursuant to 5-202 subsection "c" from the City Clerk to do the same, fires for the purpose of burning of leaves, limbs and other plant or organic wastes.

8) Fires outside the boundary of Section Thirty-six (36) in Township Three (3) South, Range Thirty-eight (38) West of the Sixth Principal Meridian, Chevenne County, Kansas, otherwise known as the square mile perimeter of the city limits of City of Bird City, Kansas.

b. During dry climatic conditions and high velocity winds in the city, the mayor may declare by proclamation an emergency and suspend burning under subsection "a" of this section. Any open burning occurring during such proclamation shall constitute a violation of this article, pun-

ishable as hereinafter provided. c. Burning permit. Upon application to the City Clerk and payment of a \$1.00 permit fee, any person living within Section Thirty-six (36) in township Three (3) South, Range Thirty-eight (38) West of the Sixth Principal Meridian, Cheyenne County, Kansas, other wise known as the square mile perimeter of the city limits of the City of Bird City, may obtain a burning permit for the burning of leaves, limbs and other plant and organic wastes within said limits of the City of Bird City. Said permit is valid for a period of 10 days from the date of issuance. Said permit may neither be transferred nor extended in the event that the permit is not used. There shall be no refunds of permit fees in the event that the permit is not used.

d. Any person setting a fire under subsection a), paragraphs 4) through 7), shall keep on had during the open burn a fully functional garden hose or a 4-A fire extin-

e. The Fire Chief or law enforcement is authorized to require any fire burning subsection a), paragraphs 4) through 7), to be immediately extinguished if such fire is determined by the Fire Chief or law enforcement to constitute a hazardous condition or are being used to burning unauthorized refuse, rubbish or trash, or if the Fire Chief or law enforcement determines that smoke emissions are offensive to oc-

cupants of the surrounding property. 5-203. PENALTY. Any person or entity

in violation of any provision herein or who

fails to immediately extinguish a fire after being directed by the Fire Chief or law enforcement under section 5-202 e), shall be guilty of an unclassified misdemeanor and punished by a fine of not more than One hundred dollars (\$100.00). In the event that a violation of this article spans a period of time in excess of one calendar day, each calendar day involved after the first calendar day shall constitute an additional and separate violation of this article.

Section 2. EXISTING CITY CODE SECTIONS REPEALED. The current Sections 5-201, 5-202 and 5-203 of Article 2 of Chapter 5 of the Code of the City of Bird City, and Ordinance 277 are hereby

Section 3. EFFECTIVE DATE. This ordinance shall take effect and be in full force and effect after its passage and publication once in the official city news-

Journalist recognized for over 40 years in newspaper

Tom Dreiling, former Goodland Daily News editor, was honored at the Kansas Press Association convention on Friday with presentation of the Clyde M. Reed Jr. Master Editor Award. He became the 15th recipient.

Dreiling was recognized for his 44 years in the newspaper business including his work at the Hays Daily News where he was photographer, sports editor and city editor in the early 1960s before moving to Goodland to become editor of the Daily

Richard Gannon, former Goodland resident and state representative, and Steve Haynes, owner of Haynes Publishing, presented the award. Haynes said he enjoyed working with Dreiling after he had hired him to be the publisher of The Colby Free Press in 1998, and later as the publisher of The Norton Telegram.

second youngest of nine children and attended high school at St. Joseph's Military Academy. now Thomas More Prep-Marian, graduating in 1953. He continued his studies at Fort Hays State University, opting out to join the United States Air Force in 1955 as the cold war was heating up. He was sent to Keesler AFB, Biloxi, Miss., where he studied International Morse Code and related courses dealing with foreign assignments. This field of study took him to Misawa, Japan, where he was stationed under the supervision of the Air Force Security Service for slightly more than two years. He was released from the Air Force in 1959 and officially discharged in 1963 after serving an eight-year active and inactive enlistment.

Returning to civilian life, he worked for a year and a half at The Ellis County Star, a Haysbased weekly newspaper before he was hired by the Hays Daily News in 1962.

Dreiling moved to Goodland in 1965, and said when he arrived at the newspaper, he asked where the reporters were, He said he was shown a desk in the corner of the front office and was told, "you're it!"

He continued to work in Goodland for nearly 24 years where he raised two sons, Lance and Todd, ages 5 and 3, after the death of his wife Jean who died of leukemia at age 37 in 1975.

When the Goodland newspaper was sold in January 1989, the new owners encouraged Dreiling to remain, but told him he would have to take a hefty cut in salary. He advised the new owners to expect his keys the following morning. For several months after leaving the newspaper, KLOE radio owner Kay Melia put him to work. He later accepted a position at Thomas More Prep-Marian as Alumni Association/Development Director; he remained at the school for six years. Dreiling was back in the news-

paper business when he moved to Sheridan, Wyo., in 1995 to

Tom opened his home to the new boys in Goodland and made them feel a part of his family. The Dreilings lived one block west of us and it was not uncommon to see the boys scaling the neighbor's fence in order to get to the other house. As the years progressed, the Smith boys were either at the Dreiling house or the Dreiling boys were at the Smith house.

'Tom was never concerned about having extra young people at his home. Overnight excursions were a source of a lot of laughter when Tom and us would get together and discuss the boys' activities. One time Troy spent the night with Lance and the boys watched a scary movie. He couldn't go to sleep, so in the middle of the night Troy got up and walked home without telling anyone. The next morning, when Tom realized he was missing a 'son' he called our house to let us know Troy was missing. What a relief to Tom when we were able to tell him Troy was home and safe in bed.

"Tom was always supportive of the boys' school activities. He always attended the cross country meets and basketball games. The Smith, Dreiling and Minner boys would play a lot of pick-up basketball games or go running together. Then they would show up either at the Dreiling house or the Smith house to hang out and
