## Politician visits St. Francis

Republican John Faber, Representative of the 120th District, was in St. Francis at Majestic Service on Thursday morning on the campaign trail. Among the topics discussed were the 1-cent sales tax increase, school funding and budgets and the Capitol remodel-

He was concerned about the tax increase which was added to the taxes earlier this year to help balance the budget. Faber stated he supported a .4-percent increase which would have been enough to help the budget. He said some towns will now have as much as a 9- and 10-cent tax so there will be many people who travel to Nebraska, Colorado and Missouri to do their spending. He talked abut the gas tax in Kansas compared to Missouri. Bud Erskin, owner of Majestic, said the state gets 24 cents on every gallon of gas and the federal government gets 18

Ryan Shay, who was at the meeting, wondered how the state got by years ago on 3- and 4-percent sales tax.

As far as school funding, he said the eastern schools are getting more and more of the funding. At one time, the weighting factor had been set up to help smaller schools. Now, the bigger

eastern schools are getting more of the weighting factor.

He and Rob Schiltz, St. Francis school superintendent, disagreed on the amount of money that small schools were getting, noting that Kansas Public Employees Retirement System (KPERS) and Capital Outlay funds were thrown into the figures.
