Hospital to sponsor spring health fair

The Cheyenne County Hospital, clinic and health department is sponsoring the spring health fair Monday to Friday. During these days, there will be blood draws, male and female exams

Screenings are offered to catch health problems like diabetes, thyroid, prostate and high blood pressure. Catching them early can reduce the risk for costly compli-

Lab work or chemistry panels are groups of tests that are routinely ordered to determine a person's general health status. They help evaluate the body's electrolyte balance and/or the status of several major body organs.

The lab draws will be offered for three mornings in St. Francis (April 11, 12 and 13) from 7 to 10 a.m. in the basement of the Cheyenne County Clinic in St. Francis and two mornings in Bird City (Tuesday and Wednesday, April 12 and 13) from 7 to 10 a.m. at the Bird City Clinic. No appointments

are needed for the lab draws.

Remember to not eat or drink except water after midnight the night before the lab draw. Those having the lab draws can take their morning prescription medications with water prior to the draws.

There will also be male and female exams available for the health fair on April 13 (afternoon), 14 and 15 (all day), in the St. Francis Clinic. In the Bird City Clinic, exams will be made April 13, 14 and 15 from 9 a.m. to noon.

Appointment for exams are a must and can be made by calling 785-332-2682. The female exams will offer breast and pelvic exams with pap smears; the male exam will include a prostate check. The fees for the labs and exams are at a reduced price and will not be charged to your insurance.

· Clean without toxic chemicals. Use gentle Castile soap and

A resolution adopting a ban of open burning in Cheyenne County, Kansas, pursuant to K.S.A. 19-101a and amendments thereto.

Whereas, the Board of County Commissioners of Cheyenne County, Kansas, determined that extremely dry conditions exist in the county, and Whereas, the Board of County Commissioners of Chevenne County, Kansas, deter-

mined that due to the dryness, the potential for uncontrollable fires exist; and

Whereas, the Board of County Commissioners of Cheyenne County, Kansas want to prevent the destruction of crops, grass, buildings and life,

NOW, THEREFORE, BE IT RESOLVED by the Board of Cheyenne County

Cheyenne County, Kansas hereby bans open burning. Open burning means any outdoor fire, including, but not limited to, burning of trash, burning of fields, pasture, fence rows, any grass land or ditches, campfires, warming fires, charcoal grill fires, except this resolution shall not apply within the city limits of the City of Saint Francis or the City of Bird City. This resolution shall be in effect from the date of execution until

such time as it is modified or rescinded by the Board of County Commissioners.

The Board of County Commissioners hereby declare that it shall be unlawful to violate this resolution and that any person found to be guilty of violating this resolution shall be subject to a fine not to be less than \$500.00 or confinement in the county jail not to exceed one month or both.
