Man seen carrying 40-pound cross

Normamartinez@wildblue.net Everyone traveling on U.S. 36 last Wednesday could not help but notice a man carrying a 40-pound cross on his shoulder and pulling a 180-pound trailer.

Mike Rumsower was passing through on his way to his destination and home in Gallitan, Mo. This journey was started on March 30 by walking across the Golden Gate Bridge in San Francisco, Calif..

It has taken longer than anticipated to get this far because of many difficulties. On this morning, he was just starting out after spending two days in the Empire Motel in St. Francis because he was not feeling well. When asked when he plans on reaching Gallitan, he said, "God's timing is different than mine," but Mr. Rumsower is guessing he will not reach his destination for at least another month.

When Mr. Rumsower was first approached, Phyllis Carson, Bird City, was just leaving after returning to bring him an Orange Crush soda, and his first words were, "Will this be from the heart and will it be about God and not me?"

He decided to do this "Calvary Trek" after having several visions. He told his pastor about the visions and he realized what God wanted him to do. On faith without advance training or backing of any kind, he packed his trailer with a tent, sleeping bag and other necessary items of his nights sleeping in his tent

and set out on his journey. "It has been trying, struggling, exhis visions he had before starting

ing," he said about his experience. People have been good to him, he said, and gave him food and money, but others have spit on him, called him crazy, and even pointed a gun at him. One man stopped and carried his cross for him for time enough to rest his shoulder.

Then he told this story: When he was walking through the desert, he was hot, thirsty and hungry and screaming to God, "Why am I here?" "What have you put me here for?" All I want, he said, was a burrito supreme from Taco Bell.

He had walked for over two and a half hours not seeing anyone when a car came over the hill and stopped.

After talking to him and sharing his feelings at the moment, they said, "God put you here for us, we needed the encouragement you have given us."

They continued talking to him even after two more cars stopped and told him the same thing. They left and as the first car started to leave the woman said, "We have these two burritos from Taco Bell, would you like to have them?" After sitting down on the road and eating them, he then realized what God's purpose was for him.

In places where he cannot find a place off from the road to sleep, he sleeps in a motel.

His goal for Aug. 24, was to reach Atwood where he had reservations made for the night. After approaching Wesleyan Church he saw cars and stopped to check things out. The church was feeding dinner to the group with the Todd Becker Foundation before their performance at the Cheylin School. Pastor Dan Carson invited him to join them to eat, then to the performance, and gave him a ride to Atwood. When he got there, his room had already been rented out, so he ended up sleeping on the floor and sharing

someone else's room. Mr. Rumsower left Cheyenne County feeling really blessed thinking Cheyenne County resident's are "from the heart, about God and not just them," he said. The people here also live up to my second expectation, "Preach the gospel, and if necessary, use words." It's 'not just people working here, but God. He said he left feeling blessed, but anxious to return home and join his three children ages 10, 9, and 7.
