# **Council decides to increase** water rates in city limits

meeting was called to order by Mayor Burr, Charles Coleman and Hal Sager presented the United States of America and State of Kansas Flags to the Mayor and City Council members. After the two presenters posted them, Mayor Burr led the visitors and council members in the Pledge of Allegiance. He suggested that all future council meetings should begin in the same manner.

#### Water rates

The water rates have been the main discussion of the city council members for months. DeAnza Ambrosier has been checking out every angle as to what is needed to bring the rates to where they need to be in order to apply for grants. In order to be considered for state funding the rates need to be at an average \$33.60 for 5,000 gallons. The way Mrs. Ambrosier figured they could accomplish this was by establishing a 40/100 plan. She suggested raising the sewer rate and base water rate by 40 percent to \$19.60. The percentage increase amount, she explained, is what the Council decided would cover the City's estimated expenses and any future loan payment. By not including any gallons of water in the base fee of \$19.60, and including a \$2.80 per 1,000 gallons fee the residents would have the conception of only paying for the water they actually use. The 40/100 rate plan would meet the states suggested average of \$33.60 for 5,000 gallons of water. Hal Sager was not in favor of taking off the 2,000 gallons from the base rate. His suggestion was to charge \$33.60 per meter and offering the inclusion of 5,000 gallons instead of the current 2,000 gallons. This way he suggested would bring them to the state average of \$33.60, and they would be able to determine what the revenue is each year. Dennis Wright did not feel this would be fair to all residents. He felt it would benefit those who use high volumes of water, but burden the residents that will never ever use the 5,000 gallons of water in a month. Mr. Sager asked Wanda Dowdy, and Charles and Val Coleman, for their opinions on this. Mrs. Dowdy replies that she knew an increase "has to be done" so she understands. The Coleman's were in agreement.

Mr. Sager moved to raise the City's water base rate to \$33.60 the Agland, Inc. contract. including up to 5,000 gallons of water, to increase the \$19.60 flat fee. The motion was carried with approached Wade Carmichael

> years as the city's contribution. Mr. Klepper said they would have a bathroom with no shower, a drinking fountain, and they plan to plant bluegrass that will require some watering. Frank Serrano was concerned about a means of calling for help in an emergency if someone was utilizing the equipment alone and ran into a medical emergency. Mr. Klepper said he will check into what procedures can be implemented. A decision was made of the council to table this until the November meeting.

> Unsafe structure demolition DeAnza Ambrosier submitted a proposed request for Bids to tear down the Old Theater structure that was determined to be an unsafe structure. City Attorney Kevin Berens said the bids needed to specify the proper amount of insurance required bythe contractors for the demolition and requirements for the disposal of the hazardous waste. These items will be looked into and discussed at the next meeting.

### **Propane contract**

Agland propane submitted the new contract for the 2011-2012 winters heating season showing a price increase from \$1.59 per gallon to \$2.05 per gallon. Mrs. DeAnza reported that during the 2009-2010 season 661 gallons of propane was used, and for 2010-2011, there were 610 gallons used. Based on this last year the City contracted for 1,000 gallons at \$1.59 per gallon. A motion was made and carried to accept
