The nospital's billing costs are outrageous, said Ernie Ketzner, commissioner.

Mr. Paulsen said the billing is part of the management agreement.

There are several repair andor replacement items needed at the Village. At the top of the list was an ice maker which will cost about \$1,800. The staff is buying ice but it is costing about \$60 per week. The commissioners agreed that this was equipment that was needed now.

The second item on the list is the asphalt paving especially on the west side where there is not only parking but also a road which leads to the airport. Mr. Paulsen said there are cracks and he wanted to know how the commissioners planned to handle this job.

The commissioners said this project had not been budgeted for. This fall, there will be a contractor doing similar work at the airport. Dave Flemming, county road and bridge supervisor, said he planned to have the company fill cracks on some of the county's asphalt roads. The commissioners will look into having the company fill the asphalt cracks at the Village. The west entrance to the

nursing home needs work, Mr. Paulsen said. The staff has raised money to have a design drawn up. Karan Thadani, county attorney, said if the staff was paying for the drawing, it was OK to have it done without advertising for bids. However, the work done on the project, which will be paid for by the county, will need to be advertised.
