The agreement was made between the secretary of Health and Human Services and the Northwest Kansas Home Care in St. Francis (not the nursing home). The facility was a home health agency provider in the Health Insurance for the Aged and Disabled Program (Medicare).

The centers for Medicare and Medicaid services etermined that the home care provider was not in
