Jeff Paulsen, administrator, said there had been a loss of \$10,766 in February. This brought on a lengthy discussion about whether or not any of the profits at the facilities stayed in the county or went to the Good Samaritan Society.

Brett Poling, commissioner, said that in January there was a profit of \$5,370, and in February, there was a loss of \$10,766. Instead of having to pay \$5,396, the difference between the January profit and the February loss, the county is paying the full loss of February.

Mr. Paulsen was unsure how this was calculated but thought it might go into a line account and, at the end of the year, it is dealt with.

Last month, NewLight Healthcare, a hospital management company, gave a presentation to the board. The county commissioners had asked the board to look and compare other options to Great Plains Health Alliance, which is the current leasing com-

Great Plains Health Alliance is up on Dec. 31, 2015. There is a 60 day termination notice in the agreement.

The hospital is currently a leased hospital with Great Plains Health Alliance. NewLight Healthcare would manage, not lease, the hospital. Being a managed hospital puts more responsibility and liability on the board members. The board makes more decisions on the inner workings of the hospital, such as hiring personnel, with a leased hospital.

NewLight Healthcare is a full hospital management service out of Austin, Texas. They have clients in over 20 states currently, but none in Kansas vet.

After some discussion on New-Light Healthcare by the board members, they went into executive session. When they came out, it was decided the board would contact NewLight Healthcare to discuss what the next step would Thursday, April 24 at 3 p.m.
