# Army cutworms may damage some wheat and alfalfa crops

Last week I had said I would have an article on soybeans.

However, with the recent rainfall, the wheat and alfalfa have greened-up which in turn has made these crops much more attractive to insects like army cutworms.

The wheat is in a very fragile state with not much growth, which can enhance the damage caused by army cutworms.

According to K-State entomologist Jeff Whitworth army cutworms have one generation a year. They lay eggs in the fall, which hatch, and the larvae overwinter. Depending on temperatures, the larvae resume feeding in late February or early March. They then grow and complete their development.

Reports indicate that cutworms are becoming a problem in Trego and Gove counties. However, farmers in Norton, Decatur, and Sheridan counties should keep their eyes open.

Cutworms feed on almost any vegetation, Whitworth said. In Kansas, however, they're usually pests in wheat and alfalfa. The larvae feed above the soil surface, but spend non-feeding time below ground. As they finish developing in the spring, they build "cells" a few inches under the surface and pupate. The adult moths typically emerge in May or June. During "outbreak" years the moths can occur in huge numbers.

Larvae seem to prefer leaves, but will eat other plant parts and may consume stems, even following them into the soil. Most feeding occurs from late afternoon until dark as the weather warms. Infestations may not be apparent under sunny conditions because the larvae seem to be sensitive to

sunlight, often hiding in the soils. Larger larvae may be apparent on cloudy days, however, they can be found by digging down an inch or two on clear days.

Small amounts of damage can go unnoticed, but when large populations occur, plants often show small or semicircular holes in leaves. The extent of the damage depends on the number and size of larvae, size of the plants, and growing conditions.

Larvae may destroy alfalfa seedlings in early spring or hurt foliage enough to reduce the amount harvested in the first cutting. Early detection is critical for good control. Seedling fields are most vulnerable and should be treated if two or more larvae per two feet are present. Established stands should be treated if four to five larvae per two feet are detected.

Poor wheat stands are most sus-

ceptible. In such situations, only one to two larvae per two feet may justify treatment. Although an insecticide may be warranted, farmers have to decide if the stand is worth saving.

As I have reported previously, wheat just emerging over the winter and early spring will have poor tillering which will lead to low seed head numbers and will reduce yield by 50 percent or more depending upon the spring.

Wheat fields with good stands probably won't need to be treated until larvae average four to five per two feet. Higher densities may be tolerated in well-tillered wheat with good growing conditions.
