## Norton City Fireworks Ordinance

**ORDINANCE NO. 1544**  
**AN ORDINANCE AMENDING SECTIONS 7-305, OF THE NORTON CITY CODE RELATING TO THE SHOOTING OR FIRING OF FIREWORKS.**

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF NORTON, KANSAS:

Section 1: Section 7-305 of the Code of the City of Norton is hereby amended to read as follows:

**7-305 Fireworks.**

A. The manufacture, sale and discharge of fireworks in the City shall be governed by the rules and regulations of the State Fire Marshall, as set out in the Kansas Administrative Regulations at 22-6-1 through 22-6-16. Such rules and regulations are hereby incorporated by reference as though set out in full herein.

B. Section 22-6-5 of the Rules and Regulations of the State Fire Marshall is hereby amended to read as follows:

The sale, offering for sale, and shooting or firing of fireworks of every nature, shall be conducted only during the days of June 27th through July 5th of each year, both dates inclusive. The physical shooting or firing of fireworks of every nature shall be prohibited between the hours of 11:00 p.m. and 8:00 a.m. on June 27th through July 5th, except that on the evening and early morning of July 4th and 5th the shooting or firing of fireworks may occur until 1:00 a.m.

Section 2: Section 7-305 is hereby amended.

Section 3. This ordinance shall be effective upon publication in the official city newspaper.

# County gives \$800 for extra fair help

The Norton County Extension office will get \$800 to hire help around fair time and, hopefully, a little more to work with in its budget next year.

Members of the Extension Council, including Daniel O'Brien, Northwest Area Extension director from Colby, and Sue Hillebrand, Steve Herrs and Kara Miller from Norton, presented the proposed 2006 budget for the extension to the Norton County commissioners on Monday.

Mr. Herrs said that they had traced expenses for the last four to five years to come up with a reasonable budget.

The major increases, he said, are a cost of living raise for the employees and an increase in travel, because that will be more expensive next year.

Besides an increase in the cost of fuel, Mr. Herrs said, Norton County has lost Brian Olson, who helped with a five-county area. A lot of what he did, including visiting farms, will have to be picked up by the Norton County staff, Mr. Herrs said.

"We anticipate that that will make a difference inside the county for travel," he said.

Major items in the budget which are expected to go up are salaries, from \$68,300 to \$71,200; travel,

from \$2,500 to \$3,500; and supplies, from \$1,400 to \$3,000. The 2005 budget is for \$100,900 and the 2006 is estimated at \$107,910.

The commissioners said that they would do what they could be couldn't make any promises. They said that they expect the county valuation to go down again next year.

"Well, we'll see what we can do when we put it all together," said Commissioner John Miller.

The extension people asked if the county would consider donating \$800 again to help with the fair. The money is used to hire part-time help during that busy time.

The commissioners agreed to donate the money to help with the fair.

"The comments that come from the public about our fair is just awesome," Mrs. Hillebrand said. "There are a lot of people that come back to this county for the fair."

"It's a safe environment," Mr. Herrs added.

"It's a community effort, that's why it works," Commissioner Leroy Lang agreed. "Everybody works together."

In other business, the extension group:

• Said thanks for the commissioners help in getting the extension office repainted and carpeted.

The commissioners pointed out that most of the work had been done by volunteers on a Saturday and Sunday.

• Told the commissioners that the county was lucky to have Keith VanSki as its extension agent.

"Keith is a good agent," Mr. O'Brien said. "A lot of counties have had turnover. Keith's a premier agent with a masters degree. We look at him for leadership in the area. We want to keep him doing well."

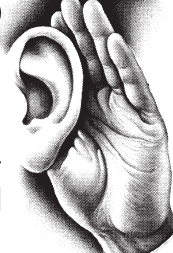
