Grace and peace to you in the name of Christ. My prayer for you today is that you will search the scriptures every day to find the answers to life's problems. "All scripture is God breathed and useful for teaching, rebuking, correcting and training in righteousness, so that the people of God may be thoroughly equipped for every good work." (2 Timothy 3:16)

In her book, *Answers Not Problems*, Mother Angelica tells us, "Day in and day out, even as we are beset with the problems and questions of life, we are called to ask for the special grace of holiness, to reject the empty promises of the world, and to embrace the answers readily available in God's word." She goes on to say that learning to believe in God becomes possible when you possess the faith, hope and love taught in I Corinthians 13. She defines them like this: "Faith is what gets you started, hope is what keeps you going, and love is what brings you to the end."

Faith obtains for us only what is in the play of God and will be for our good. Hope gives us the assurance that our God is real and keeps his promises. It gives us joy in sorrow and peace in the turmoil of life. Love is a decision, not just a feeling. May you love as God loves, freely and endlessly, because love is the whole point of Christianity.
