

ORDINANCE NO. 332 AN ORDINANCE REGULATING PUBLIC OFFENSES WITHIN THE CORPORATE LIMITS OF THE CITY LENORA KANSAS; OF INCORPORATING BY REFERENCE THE "UNIFORM PUBLIC OFFENSE CODE FOR KANSAS CITIES.' EDITION 2006

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF LENORA, KANSAS:

SECTION 1: INCORPORATING UNIFORM PUBLIC OFFENSE CODE. There is hereby incorporated by reference for the purpose of regulating public offenses within the City of Lenora, Kansas that certain code known as the 'Uniform Public Offense Code' Edition 2006, prepared and published by the League of Kansas Municipalities, Topeka, Kansas. No fewer than two copies of said Uniform Public Offense Code will be marked or stamped "Official Copy as Adopted by Ordinance No. 332," and to which shall be attached a copy of this ordinance, and filed with the city clerk to be open to inspection and available to the public at all reasonable hours

SECTION 2: AMENDMENT. Section l of Ordinance 328 is hereby amended and replaced by Section 1 of this ordinance.

SECTION 3: EFFECTIVE DATE. This ordinance shall take effect and be in force from and after its publication in the official city newspaper.
