She said students can come to the facility, itself, or work on-line at home. The center is open Monday through Thursday from 8 a.m. to 8 p.m. and Friday from 8 a.m. to 3 p.m.

Norton school superintendent Greg Mann added that the student will earn a Norton Community High School diploma, not a General Education Diploma (GED). He also said that if a drop-out from the high


