Psalm 100 "Shout for joy to the

Lord, all the earth. Worship the Lord with

Him with joyful songs. Know that the Lord is God.

It is He who made us, people, the sheep of His pasture. Enter His gates with thanks giving and His courts with praise; Give thanks to Him and praise His Name.

For the Lord is good and his love endures forever; His faithfulness continues through all generations.<sup>3</sup>

Psalm 100 is indeed a psalm of praise. Thus, this passage of Scripture should be wholeheartedly looked to when considering what true thanks giving to God is all about.

The Hebrew word for "shout" literally means, with an expression that can be easily heard, you are to shout for joy to the Lord. Just as Norton Blue Jay fans shout for joy when their hometown team makes a touchdown in a football game, Spirit-filled, born again Christians are to give a loud praise unto the Lord for His great works.
