"I believe those elite programs have a lot in common with the Norton FFA. Year in and year out, the Norton FFA competes at a very high level.

"To have elite programs in basketball, it takes a variety of things and I think the same is true of the Norton FFA.

There are days when the players aren't feeling like doing what it takes to compete at that high level and that's where the right coach can get the maximum out of the players. I'm sure there are days when the coach isn't having his best day either and that is when the players support the coach.

"Atrue elite program also equips their players to succeed in life. The coach knows the time he has with his players is limited. Mr. B and the Norton FFA are also aware of this limitation and have positively impacted many young people during the time they have."

One of them enrolled at Kansas State University intending to become a veterinarian but words from Mr. Beydler prompted him to check out the milling science department. He decided the milling science was more of a fit for him and graduated in 1992 in milling science.

would not be chip sealed, and that the city would be responsible for getting the road open after snow and the homeowners would be responsible for opening their own driveways.

Following the discussion, Ron Briery made a motion, seconded by Elaine Mann, to accept Timbercreek Circle and have the city attorney prepare the legal documents required for the project. The motion was approved.

Adiscussion concerning a local website also surfaced. Mayor David Corns said he knows that the website, toby4Norton.com, was probably put together with the best of intentions, but there were some tasteless comments posted on it. Jeff Otter, who was successful in his election bid to the council at the April 1 election — winning over incumbent Jerry Jones - thought everyone has the right to express themselves. Mr. Kuhn, who also won election to the council on April 1 defeating Wally Burton, said his original intent was not to have negative comments posted. but as the administrator of the site, he didn't think it was his responsibility to censor people's opinions. His felt it was important to have some type of open forum for discussion.

In other happenings at the meeting:

- A motion was made by Kim Snyder and seconded by Jerry Jones to waive the formal third reading and adopt Ordinance #1572 increasing the Mayor and Council compensation to an amount of \$350 per month. The motion failed. Voting yes were Kim Snyder and Jim Williams, with Jerry Jones, Donna Foley, Elaine Mann and Ron Briery voting no.

- A motion was made by Donna Foley and seconded by Elaine Mann to waive the formal second reading of Ordinance #1573, designating a stop intersection at E. Waverly and No. Archer, stopping southbound traffic on N. Archer Street. The motion carried.

A motion was made by Ron Briery and seconded by Elaine Mann, to approve purchase of a sign to be installed in front of the Norton Public Library at a cost not to exceed \$3,000, with the money coming from the Hansen Foundation. The sign would be brick to match the exterior of the library and will follow KDOT

paint. Motion by Ron Briery and seconded by Elaine Mann would allow Mr. Lawson to hire a local contractor or individual to finish the sheetrock and painting of the library building walls, with the cost not to exceed the budget remaining in the Library Bond fund. Motion carried.

- Tim Bashford said the city needs to see if grant money is available for a new swimming pool. Mayor Corns said the question on this month's city bills is just a survey to see how the citizens feel on issuing bonds to fund the construction of a new pool. Mr. Bashford also wondered if the city pays for commercial curb replacement. Mr. Lawson said the city's curb replacement policy includes residential and commercial. Mr. Bashford said the city has streets in town that are in bad shape, and in reference to Timbercreek, they are accepting another one to maintain.

 Ron Briery made a motion, seconded by Donna Foley, to approve Curt Walter's request for 98 feet of sidewalk replacement at 124 S. Second Street, with condition that the city provide labor and the property owner pay the cost of materials directly to the concrete provider. Motion carried.

 Motion by Ron Briery, seconded by Jerry Jones, to approve Tony Grysch's request for 300 feet of curb replacement at 301 E. Main, with the city paying the cost of the concrete, and the owner paying a private contractor for the labor. Motion carried.

 Mr. Lawson reported a new mower was budgeted for 2008 for the water and wastewater plant. Elaine Mann made a motion, and Kim Snyder seconded, to accept the low bid from Jacobs Service Center for a new mower in the amount of \$4,835.22. Jacobs would have a loaner available if the new mower would need any warranty work. The motion carried.

- Mr. Lawson also stated a utility vehicle was also budgeted for 2008 for the water and wastewater plant. A motion was made by Elaine Mann and seconded by Kim Snyder to accept the bid from Norton Sports Center for a Kawasaki utility vehicle, plus options, at a cost of \$9,097.45. This was the lone bid received. The utility vehicle will be used for pushing snow and traveling back and forth

to hire someone to sheetrock and as soon as the bridge is built. It will also be used by other departments. The motion carried.

 Mayor Corns reported city sales tax receipts collected in February of 2008 totaled \$21,684.95, and the county sales tax receipts totaled \$17,805.50 for a total of \$39,490.45. The 2008 year to date sales tax receipts total \$130,272.50.

 Several change orders were approved for: the containment steps and walkover handrails at the water treatment plant at a cost of \$2,650; installation of pump controllers for the polymer pumps at the water treatment plant at a cost of \$1,197; and for installation of two motor starters for the mixers in the old chemical feed room, and installation of one disconnect for the heater in the old chemical feed room at a cost of \$4,375.

 Mr. Lawson reported that the Kansas Department of Health and Environment has released the City of Norton from the Consent Agreement at the Sewer Plant. He said BRB Contractors has offered to extend the warranty period from one year after date of final completion to three years after date of final completion for leakage on the piping systems and for leakage from the concrete tanks comprising CCA No. 1 and No. 2, and the aerobic digester at the sewer plant. This warranty extension, he said, is being offered in lieu of providing documentation that these systems were treated before the sewer plant was put online. Elaine Mann motioned and Ron Briery seconded to accept the warranty extension. The motion carried.

 The following building permits were presented: Rich Meyers, \$10,000, extend garage at 710 Sun Avenue; Jeff Otter, \$500, to demolish house at 310 N. Norton Ave.; and Todd Boller, \$10,000, to construct garage at 806 N. Grant.
