

Not enough money for repairs

c.haynes@nwkansas.com Norton County has some money to rebuild and repair bridges - but not enough.

Steve Berland of BG Consultants, the county's engineering firm, told the commissioners on Monday that there is \$165,000 left in the bridge project funds. This money can only be used to replace bridges, he said.

However, that isn't enough to even fix the Stinger Bridge also known as OS186, which is two miles east of Edmond and 1/2 mile south of K9.

'Just say no' to this latest scam

Lady Nancy Reagan's advice to the nation's young people when confronted with drug use.

Now, for our older residents here in Norton and elsewhere maybe that piece of advice from Mrs. Reagan so many years ago, could be applied today to what Sandy Praeger, Commissioner of Insurance, calls a "company settlement" scam whereby a phone solicitation promising settlement money supposedly offered by people who bring it in will have to a large insurance company has unfolded.

> Commissioner Praeger's department has identified at least one Wichita-area woman who sent money to persons in Canada and Texas for release of so-called settlement funds from a lottery scam. Through phone calls from a purported insurance agent of a large national company, the woman was told 11 times to send money. The woman was not a policyholder of the company but had been a victim of the lottery scam several years ago. Nine of the 11 wire transfers were to the

"Just say no," was former First same address in Canada.

The same "agent," according to Mrs. Praeger's office, made calls to the woman each time. A man with the same name has been identified on a consumer alert in the state of New York on a similar type of solicitation. The woman reported the solicitation after the wire company identified one of the fund receivers in Canada as being listed on a scam alert.

"It is essential for Kansans to be alert and vigilant against these fraudulent activities," Commissioner Praeger said. "In this case the perpetrators came back to a victim of another scam and used that to defraud her again."

"We urge people to follow the 'Stop. Call. Confirm' method for evaluating any insurance solicitations you believe are suspect,"

Livestock producers aided

Agency, said Wednesday that certain acreage enrolled in the Conservation Reserve Program is available for having and grazing after the primary nesting season.

"This authorization provides relief for many Kansas livestock producers," said Fuller. "The high price and demand of commodities has significantly impacted the Kansas livestock industry."

More than 2.5 million acres of CRP land in Kansas will be eligible for this critical feed use.

Conservation Reserve Program acreage in all Kansas counties that is fully established and devoted to the following CRP practices will be eligible:

CP1, Established Permanent Grasses and Legumes

CP2, Established Permanent Native Grasses

CP4B, Permanent Wildlife Habitat - Corridors

CP4D, Permanent Wildlife Habitat

CP10, Vegetative Cover CP18B, Established Permanent Vegetation to Reduce Salinity

CP18C, Established Permanent Salt Tolerant Vegetative Cover

Participants must leave at least 50 percent of eligible CRP acreage unhayed for wildlife. Grazing can be conducted at 75 percent of the Natural Resources Conservation Service recommended stocking rate on 100 percent of the eligible acres or at 100 percent of the stocking rate on 75 percent of the eligible acres.

Environmentally sensitive land such as wetlands, buffers, and filter strips are not eligible for haying or grazing, along with acreage

> Haying and grazing cannot begin until July 16 and must end by November 10. Having and grazing is not allowed on the same acreage. HCRP participants may sell the hay, or use their CRP acreage for their own use or lease to any other individual. No payment reduction will be assessed, but CRP participants will be required to pay a \$75 fee per contract to modify their contract to allow having and grazing in 2008.
