The American Legion's Rich Miller will make the presentation in favor of the proposal.


Schools to dismiss early on Nov. 11

Norton County goes McCain

Deer wrecks climb

Deer-related accidents, unfortunately, seem to be the norm now in Norton County. Within the past couple of weeks the 'Accident Report' appearing in The Telegram, told of 13 deer-related collisions.

Damages, for the most part, were in excess of \$1,000. For the most part, drivers had no choice but to slam into the deer as they walked onto the highways and roadways.

Sandy Praeger, Kansas Commissioner of Insurance, said a few days ago that the steadily rising numbers of deer-vehicle accidents call for an emphasis on defensive driving.

She said more than 200 such accidents occurred on Kansas roads in 2007 than in 2006. And from the looks of things, 2008 may top 2007.

The Kansas Department of Transportation said the total for all deer accidents in the state in 2007 was 9,417 compared to 9,197 in 2006. The 2007 statistics resulted in five deaths and injuries to 298 motorists. Those were higher numbers than the year prior.

"A frightening reality of driving on Kansas roads and highways this time of year is the possibility of an unexpected encounter with a deer," the insurance commissioner said. "I urge Kansans to drive cautiously, especially around sunrise and sunset.'

Statistics show that one in every 100 drivers nationally is likely to have a wreck with a deer at some time during their driving years. Mid-fall and mid-spring are likely times of the year for deer to be seen on roadways, because of breeding habits during the fall and growth of vegetation

Tuesday's election in Norton County brought 2,472 voters to the polls, out of the 3,728 registered for a turnout of 67 percent. That was not, however, a record, according to County Clerk Robert Wyatt who said in the 2000 election 70 percent of the registered voters cast ballots.

"This was certainly one of the largest voter turnouts in Norton County in the last 10 years," Mr. Wyatt, said. "I'm very pleased with the turnout and interest prior to the election. We had a lot of phone calls from people asking about registration and where they're supposed to vote in the weeks prior to the election."

Mr. Wyatt said there was a very long line when he unlocked the doors at the American Legion at 7 a.m., and for about 30 minutes the building was packed. There was also an influx of voters during the lunch hour and again after normal working hours.

Here's how the Norton County voters marked their ballots:

President: The McCain/Palin ticket (Republican) received the most votes with 1,836, while the Obama/Biden ticket (Democrat) received 488 votes. Nader/ Gonzalez (Independent nominations) received 23 votes; Barr/Root (Libertarian) 10; and Baldwin/Castle (Reform) 4.

Rep. Faber wins re-election bid

Republican incumbent John Faber was re-elected to his 120th District House seat in Tuesday's general election

Unofficial results gave Mr. Faber 6,605 votes to 2,571 for Democratic challenger, Bob Strevey.

U.S. Senate: Roberts (Republican) received 1,906 votes; Slattery (Democrat) 391; Hodgkinson (Libertarian) 36; and Martin (Reform) 20.

District: Moran 2,084 votes; Bordonaro (Democrat) 166; Burton (Reform) 47; and Warner (Libertarian) 37.

40th Senate District: Senator Ostmeyer (Republican), unopposed 2,044.

120th House District: Representative Faber (Republican, 1,433 and Bob Strevey (Democrat) had 866.

17th Judicial District Court Judge: Judge Elliott (Republican), unopposed, 2,071.

County Commissioner, 2nd District: Applegate (Republican), unopposed, 580.

County Commissioner, 3rd District: Miller (Republican) 495, and write-in candidate Ellis, 263.

By county, here is the breakdown: Cheyenne, Faber 1,212; Strevey 204.

Rawlins, Faber 1,191; Strevey 316. Decatur, Faber 924; Strevey 547. Norton, Faber 1,433; Strevey 866. Phillips: Faber 1,845; Strevey 638.

Norton County offices (all unopposed, all Republicans): Wyatt, County Clerk, 2,059 votes; Linner, County Treasurer, 2,123; Vincent, Register of Deeds, 2,172; **U.S. House of Representatives, 1st** Sebelius, County Attorney, 1,976; and Thomson, Sheriff, 2,081.

> Almena Township voted Chandler (Republican) for Trustee with 215 votes and Williams (Republican) for Treasurer with 226 votes.

Also on Tuesday's ballot were questions on retaining judges in the Kansas Supreme Court and the Kansas Court of Appeals. In Norton County, all the judges were re-elected: Rosen, 1,327 yes and 493 no; Johnson, 1,318 yes and 500 no; Leben, 1,312 yes and 484 no; Pierron, 1,297 yes and 493 no; Marquardt, 1,307 yes and 485 no; and Greene, 1,382 yes and 419 no.

The ballots will be canvassed on Monday.

A rash of vehicle thefts in Norton has been reported by local law enforcement. The owners find their vehicles missing when leaving the next morning for work. The vehicles in question were taken during the last two weeks of October.

"Residents should not leave their keys in the vehicles and need to be locking the doors and removing their valuables when they go in for the evening," said Norton Chief of Police Pat Morel. "If you see any suspicious people hanging around, call 911 or the police department at 877-5010."

A total of four vehicles have been taken from their owners' residences and parked in a different location. Two vehicles taken on different nights were found parked in the exact same spot a couple of days apart. Two others appeared to have been rifled through.

"It is considered Criminal Deprivation of Property, a Class A misdemeanor," said Chief Morel. "The first conviction is 30 to 365 days in jail and a fine of no less than \$100. The second conviction carries a jail term of 60 to 365 days in jail and a fine of no less than \$200.

Chief Morel said the department is investigating the incidents, and could not give out any more details of the incidents
