The Bikes For Youngsters program takes donated bicycles and refurbishes them to like new condition. The bikes are then distributed by charity organizations to families in the region and throughout the state. There are six inmates who restore the bikes.

This year you may pay your taxes online with a credit card or checking account. That website is www.kansas.gov/propertytax. If you have questions, please give us a call at (785) 877-5795.

The deadline to renew your automobile, light truck, motorcycle or motorized bike

tags if your last name or business name begins with "U", "X", "Y" or "Z" is Dec. 31. When renewing your vehicles, remember to include your current proof of insurance for all vehicles.

We need to verify the VIN number, policy number and current expiration date.

# Deep freeze hits Oberlin school

k.davis@nwkansas.com A pile of colorful, handmade afghans and blankets sit in the corner on the top step in the vocal music room at Decatur Community High.

A big red space heater stands in the middle of the top step, running on high to help heat the room.

With temperatures outside dropping to the single digits Monday and the wind chill a minus 11, those blankets and heaters were put to good use, as the older front section of the building doesn't always have heat.

Garrett's Plumbing of Norton has been replacing a steam condensation line for the heating system since October. That means since then the older section of the school hasn't had 24-hour heat yet this winter. The heater had been turned on every night, but since the sump pump broke and the new one isn't in yet, someone has to be at the school when it runs.

Students, teachers and staff have had to wear coats, sweatshirts and in some cases wrap up in blankets to stay warm.

"It was 45 degrees in our classroom this morning," said Mary Jo Lohoefener, who plays the piano a few hours a day at the high school.

She said they haven't had heat all year, and although the classes have worked around it, it's crazy.

On Monday, the students went to the cafeteria, in the new back part of the building, to practice, because the music room was too cold. Mrs.

Lohoefener said they have space heaters, but they blew a fuse on Monday.

Around 2 p.m., the heat in the vocal room got up to 55 degrees as the temperatures outside reached a toasty 9 degrees.

Superintendent Pat Cullen said the heating system was turned on Monday afternoon and things were warming up nicely. It's cold outside, he said, and it takes a while to heat up the building. Even when the system is running all the time, he said, it takes some time to warm up.

When the plumbers started the job, said Principal Charlie Haag, it wasn't as cold outside. Then as the project got underway, one thing led to another.

Parts had to be ordered. When the plumbers aren't working on the system, he added, it can be turned on.

Just recently, a sump pump in the basement broke. That meant the system couldn't be left on at night because the basement could fill up with water. At the school board meeting last week, the members approved buying a new pump.

Mr. Haag said they are using a smaller one, but in order for the heating system to be left on, someone has to be in the building. Kenny Black, district maintenance supervisor, started the system at 4 a.m. Monday, said Mr. Haag, and will probably do that all week.

The heating system then can run in the morning to get things heated up, he said, but then in order for the plumbers to work on the system, it has to be turned off.

Students have been moved around to different rooms, he said, and things have worked out. The heating system that's being worked on serves eight classrooms, the auditorium, the old gym and the vocal wing, said Mr. Haag. The rest of the high school is on a different system, which is working fine.

Dr. Cullen said he hasn't really received many complaints about the heat, although he has gotten some comments about it being cold.

"I think most people are understanding," he said.

The condensation line is being replaced now, said Dr. Cullen. Ithad to be done because of wear and tear over the last 80 plus years. When it failed last year, it caused at least \$30,000 in damage.

The district has a new boiler for the system, he said, but that probably won't be put in until the spring or summer when the heat isn't needed unless it has to be done before that, he added.

Everyone knows the high school is in the middle of a major renovation, said Dr. Cullen, It's about 90 percent complete. The project will probably take another week or two to be finished, he said, so probably by the end of Christmas break, the heat will be running as usual.

According to the National Weather Service in Goodland, the forecast for the rest of the week is for more cold, with a high on Tuesday of 21 and wind chill at minus 19. The high should be 23 today, up to 32 on Thursday and 29 on Friday.

# Recycling numbers show increase; city officer turns in resignation

(Continued from Page 1) malt beverage licenses for 2009 brought before them, which included Jamboree Foods, Love's, 1st Stop, Pamida, Pizza Hut, Town and Country and Rainbow Lanes. Councilman Briery asked why the Stonehouse Restaurant had not applied for a license. Mrs. Ellis said she thought the owners of the restaurant are applying to the state for a club license.

• Mr. Lawson gave his report. He said the council approved budgeting for a 3 percent cost of living increase for 2009, and after some

research, he found that the the 128,760 pounds of recyclables most a city has approved for cost of living increase is 5.8 percent, and the least is 3.7 percent. Mr. Lawson said the increase would be for all city employees, and that it would take effect for the first full pay period of 2009. The city approved a 3 percent cost of living increase.

Mr. Lawson said that between January 2008 and August 2008, the city collected 59,320 pounds of recyclables, between August 2008 and December 2008, it was 69,440 pounds, for a total of collected from city residents in 2008. Mr. Lawson also noted that there are still a few recycling cans available at the city office for no charge to Norton residents who request one.

Councilwoman Mann asked if after collecting all those recyclables, did the landfill fees go down. Mr. Lawson said the fees did go down.

Councilman Briery said he thought the free recycling bins really helped people be able to recycle.

Mr. Lawson said there is a request from Don McMullen and Jerry Bantam to use Elmwood Park Speedway for the annual vintage races. Mr. Lawson also said that he has spoken with Mr. McMullen, and if the city has not found a race promoter by then, he would be the promoter for it.

The council approved the request to use the speedway for the vintage races.

Mr. Lawson reported to the council that police officer Curtis Black has given his two-weeks notice. Officer Black's last day

will be Dec. 26, after which, he the equipment can also be used is moving to a new city.

• The council went into executive session for 20 minutes. Upon resuming open meeting, no action was taken.

• Councilman Briery asked the council to approve setting aside \$15,000 from the capital outlay funds for the purchase of a back hoe and jackhammer to use on curb and gutter work in the city. The council approved the motion, and Councilwoman Mann said she is excited about it, and thinks it is a good move because

(Continued from Page 1) "We like to use the old-style bikes, the ones with fenders and baskets, for the elderly," said Mr. Annon. "Finding a threewheeled bike is a rare thing, and those are what we like to use for the seniors that don't have a vehicle. They can keep some of their independence and still have transportation."

Hays, and area churches. Mr. Annon said it can take any where between one and five days to refurbish a bike, depending on the condition of the bike and the parts available for repairs. "The parts themselves are very expensive," said Mr. Annon. "To help defray that cost, we take bikes in any and all conditions, and if we can't get a bike back into good working order, we'll salvage the parts of it that are still good and take the rest to F and F Iron for money. The money we get from that is used to buy supplies or parts for the shop.' Mr. Annon stressed that the program is not a repair shop, and the bicycles they restore are not for sale. Families who need a bike should not call the prison to ask for one, but go through their church or a local charity instead. And most importantly, the shop will take any bike in any condition "We've even gotten bikes from city clean-ups in the area," said Mr. Annon. "We've gotten bikes from Hays, Colby, Phillipsburg, Oberlin, Hill City and even a couple of bikes from Goodland." The program will never turn a bike away. To donate a bike or money to the program, call the Bikes For Youngsters shop at (785) 877-3301, extension 341.

In 2006, the program won an award at the Kansas State Fair in a contest that was sponsored by the Kansas Department of Health and Environment called "Get Caught Recycling!"

"Out of over 400 entries in the contest, Bikes For Youngsters was one of 11 who received an award," said Mr. Annon. "We are very proud of that."

In October 2007, with the help of George Jones, Norton, and the Norton Christian Church sent 153 refurbished and rebuilt bikes to Greensburg.

"They sent us pictures of the kids on their bikes," said Mr. Annon. "It was a really good feeling for all of us to see that.'

Some of the organizations that request bikes from the program are Big Brothers/Big Sisters, the Norton Senior Center, Social and Rehabilitation Services, Court Appointed Special Advocate, Youthville in Phillipsburg and
