

Focus now is on Kansas Day

With Kansas Day coming up on Thursday, it is time to turn our focus on Kansas and some of Norton County’s participation in the festivities.

Recently, Norton County was represented at the reorganizational meeting for the Republican Party in the First Congressional District of Kansas on Dec. 13, 2008 in Hays. Of the counties in the northwest corner of Kansas, Norton was one of the few to be represented. Those attending were the chair of the Norton County Republican Central Committee, Steve Berry, along with vice chair Rebecca Wetter. Being that both are officers, each was a delegate from Norton County with the designation of voting for the slate of officers for the party in the First Congressional District and 37 delegates to the state committee.

While waiting for the tally of the voting on the slate of officers and the delegates, Representatives Deana Horst and John Faber spoke and answered questions from the

floor, as did Sen. Tim Huelskamp. The budget of Kansas was the main topic, with all stating the already known deficit. The interesting question from the floor was, “Is the legislature going to pursue a reimbursement from Governor Sebelius for the use of the state plane for political purposes other than state business and the use of taxpayers’ money for some of the parties thrown?” We were advised to write our legislators with our concerns.

It was also brought out that our representation is declining in western Kansas; we have five representatives compared to the seven in Johnson County alone. ‘Speak up western Kansas and keep us informed,’ were the ending thoughts of these legislators as they respectively finished their addresses.

As the tally of the voting was announced, Norton County found themselves represented on the state committee through delegate Steve Berry. The state commit-

tee meets during the activities of Kansas Day.

These events had brought the meeting to a lunch break and Rep. Jerry Moran to listen to. Rep. Moran gave a brief bio of himself and touched on current issues to come before Congress when they reconvene. In closing, he stated to keep him informed.

Our seats were resumed to vote for alternates to the state committee. With that soon accomplished, the meeting was adjourned.

As this year starts, let us remember it is the participation of people from the local level that gets northwest/western Kansas heard. That includes you communicating with your county commissioners, state representatives and senators, and U.S. Representatives and Senators to help keep them the statesmen they are elected to be.

Busy day for county 4-H’ers

4-H members were busy cooking up dishes and designing place settings Saturday at the Annual 4-H Favorite Foods show. Judges Janelle VanKooten, Hays, Barb Eckols, Hill City, and Edith McClain, Gaylord, talked with the 23 contestants about meal preparation techniques, nutritional values of the foods, how the favorite foods fit into a menu, the food guide pyramid, and the presentation of the food in a table setting.

The 4-H members had to select table linens, place settings and centerpieces for their displays to represent a table setting for a meal or snack where their “favorite food” would be served.

Of the 23 members who prepared foods for the show, there were four outstanding ratings given, one in each of the Foods and Nutrition levels.

Top purple in Level I was awarded to Shane Cozad, Norton, a member of the Busy Beavers 4-H Club, for his Peanut Butter Cookies.

“I made the peanut butter cookies because I like them,” said Shane. “They’re my favorite. I might do something else next year. I think I have an idea what it will be.”

Shane said he was surprised to win the top prize, and that it only took about 30 minutes per batch to make.

Top purple in Level II was awarded to Molly Maddy, Norton, a member of the Busy Jayhawkers 4-H Club, for her Chicken Sour Cream Enchiladas.

“I wanted to do this recipe because it looked challenging and I like enchiladas,” said Molly. “I was surprised to win.”

Molly said she will probably enter again next year, though she doesn’t know yet what recipe she will do.

Top purple in Level III was Macy Kasson, Norton, a member of the Cedar Ridge 4-H Club, for Macy’s Favorite Breakfast Casserole.

“I made this because I really like it,” said Macy. “Mom’s made it a lot and it’s my favorite food. It wasn’t hard to make; it only took half an hour. I had to make it three days in a row to practice, and I

think we all got kinda sick of the casserole.”

Macy said this is the first year he’s won top purple at the favorite foods show, but he’s always gotten a purple ribbon in the past.

Top purple in Level IV was Carissa Wentz, Norton, a member of the Prairie Dog 4-H Club, for her Chocolate Covered Strawberries.

“I thought this looked good,” said Carissa. “It took about an hour and a half. I was surprised to win.”

“These kids were awesome,” said judge McClain. “I was impressed with the younger ones as well as the older ones. I’m amazed at the table settings knowledge with what to put with the food. I am very, very impressed.”

The 4-H Favorite Foods show has been an annual event for at least 30 years, though no one can remember exactly when it started.

“This was something for the 4-H members to do in the winter when things have slowed down,” said Beverly Kindler. “There are food shows during the summer, but they all have to be non-perishable. With this, they can make their favorite food, and it can be perishable.”

Purple ribbons were awarded to Kailey Gill, Busy Beavers, for S’mores Brownie Bites; Micah Kasson, Cedar Ridge, for Chocolate Chip Cake; Amy Wentz, Prairie Dog, for Easy Layered Delight; Bryndon Wentz, Prairie Dog, Cinnamon Apple Pizza; Tyson Gill, Busy Beavers, for Cheeseburger Macaroni; Carson Wallace, Cedar Ridge, Super Bowl Stromboli; Quentin Wentz, Prairie Dog, for Walk-Along Chili; Megan Wentz, Prairie Dog, for Chocolate Souffle; Wyatt Wentz, Prairie Dog, for Pizza Stromboli; Morgan Baumann, Busy Beavers, for

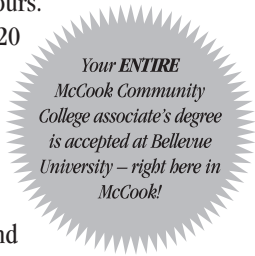
