As for Dante's reference to neutrality, I claim absolute innocence. Our views may differ, but that is different from neutrality. I am anything but neutral.

Am I an avid abortionist? Absolutely not. Do I think abortion is the answer, definitely no.

Some say abortions need to be illegal because without them their handicapped child would have been aborted. Legalized abortion does not mean mandatory abortion. If the law is all that keeps someone from stealing, aborting or murdering, they have more than one problem to address.

On a personal level, I can't imagine any circumstance where I would have an abortion. For me it would be wrong, but I am not everyone. I have not walked in everyone's shoes.

The letter stated 48,589,993 babies have been aborted since the 1973 Roe vs. Wade. Two million children are beaten each year by a family member, this is 72 million since 1973. (Victim Assistance Program) For whatever reason, pregnant women decide to terminate their preg-





nancy, probably with reasons as varied as the fetuses they carry. In my ideal world there would be no abortions.
