# **2010 Norton Relay** for Life is planned

Special to The Telegram Y'all come! That means everyone is invited to attend all or part of the activities at the 2010 Norton County Relay for Life, scheduled to begin at 7 p.m. on June 25 and end about 7 a.m. on June 26 with clean-up and breakfast.

The activities will begin with the presentation of the colors by the American Legion, while Jeremy Wetter plays the National Anthem on his trumpet. The invocation will be offered by the Rev. Darel Boston. Then the survivors, clad in this year's purple Relay shirts, will introduce themselves and tell how long they have been survivors and then walk the Survivors' Lap. The second lap will be the caretakers, honoring all those who care for or have cared for cancer patients. Then members of the 10 teams will begin their all-night walk.

During the evening several people will speak. This year's Honored Guest, Rich Miller. will give a brief address. Miller is the administrator of Norton County Hospital. Survivor speakers will be Jill Lively and Kaylene Hahn. Marvin Manchett will be the Master of Ceremonies and music will be provided by Larry Henderson and LeeAnn Shearer. At 9:30 a "Fight Back" ceremony will occur.

The entertainment committee has been making some secret plans, as well as promising a repeat of last year's popular frozen tee shirt contest. There will be a dunk tank, so perhaps you'd like to take your chance at sending someone splashing into water. Other games and competitions, including a poker run or in this case a "poker walk" are planned. A free movie will be shown at midnight.

The event was moved to the Courthouse Square this year from Elmwood Park, in part to encourage more community support and involvement. A rain site will be the Rec Center. Because the Relay was called off three of the last four years, it was deemed necessary to have a back-up plan. This year a Table of Remembrance, honoring those no longer with us, will be set up on the stage area. Also new this year will be a birthday cake where each survivor may light a candle to celebrate having more birthdays.

For many people the highlight of the evening is the luminaria ceremony. All people being honored or remembered by having a luminaria placed around the walk track will have their names read as the candles are lit. This takes place about 10 p.m., after the sun has set and it is dark. "It is a very moving experience," share those who have in some way participated.

In addition to the Relay, a survivors' reception is being held on June 18 at 7 p.m. in the conference room, in the basement, of Norton County Hospital. If someone is a survivor and hasn't signed he or she may do so that evening. There will be refreshments and someone will be sharing a personal experience. All monies for luminaries must be turned in that evening if the names of persons to be honored are to be read at the luminaria ceremony at the Relay.

## Tags need to be renewed

The last day for businesses or persons whose name begins with "H" or "I" to renew automobile, light trucks, motorcycles and/or motorized bikes tags at the Norton County Treasurer's Office will be June 30.

When renewing your vehicles remember to include your current proof of insurance. We need to verify the VIN number, policy

number and expiration date. In addition to insurance we need your driver license number or Federal ID number for the business.

Driver license renewals can be done Tuesday through Friday from 8 a.m. to 4 p.m. Instructional permits (IP) and Driver Education restricted licenses can be done in the office by appointment only. You will need to bring an origi-

nal state issued certified birth certificate, social security card for the applicant and a utility bill with current address plus the driver license of the parent that brings the child.
