Rep. Faber begins re-election campaign

Rep. Faber, a 14–year member of the Kansas House of Representatives, started his re-election campaign as of June 7, after filing for office.

"It has been an honor and privilege to represent the people of the 120th district," Faber said.

Faber currently serves as a member of the Appropriations Committee, chairman of the Agriculture and Natural Resources Budget Committee and the Public Safety Budget Committee. John Faber is the only member of the House that has been given the responsibility of serving on three budget committees.

He also serves as a member of the Joint Committee on Rules and Regulations, a committee that deals with home-owned carnivals as well as all agency regulations.

As chairman of the Agriculture and Natural Resources Budget Committee, John Faber oversees all Agriculture budgets including Department of Agriculture, Animal Health, Conservation Commission, Wildlife and Parks, Department of Commerce, Kansas State Fair and most of the fee funded agencies including Kansas Cooperation Commission, Veterinary Board of Examiners, Banking Commissioner and many others.

"First, I want to make sure that Agriculture is on sound footing," Faber said. As a farmer and former agriculture chairman and now budget chair, Faber has a leadership role that is grounded in the most important issues facing his constituents in the 120th district.

As chairman, John was able to restore the 19 million dollars that had been mistakenly deleted from the attorney generals budget to litigate water issues with our surrounding states.

He was able to convince the legislature to restore the funding in a year when revenue was not available and did it by giving the attorney general the authority to request Bonding Authority to litigate ongoing water issues. Any litigation funding coming from that source would replace the dollars that had been bonded first. As Rep. Faber stated at the podium on the house floor, "If you aren't ready to fight for water then you had better get used to using less of it."

As chairman, Rep. Faber was able to make sure that our state

parks have enough money to stay open and viable. He did this by allowing Wildlife and Parks to use dollars from other funding sources on the parks portion of the budget. As of today, the parks division has hit record numbers in usage.

As a member of the Transportation and Public Safety Budget Committee, John was able to convince the committee to restore the cut to the Norton Correctional Facility and re-open the Stockton facility.

His leadership met fierce opposition on the house floor as a large group from the urban area of Wichita and El Dorado wanted the funding to go to the El Dorado Facility. He convinced the legislature to stick with the Stockton Facility and prevailed on that issue.

With the help of state Sen. Ralph Ostmeyer and other rural legislators, John was able to mitigate the issue that dealt with inspections of our "home-owned carnivals," and this was not an easy task as this is a Western Kansas issue that is not understood by the majority of the legislature but is so important to all the county fairs in his district. As a member of the Joint Committee on Rules and Regulations, this is an ongoing issue and will have to be monitored closely.

Rep. Faber has supported education in rural Kansas. He supported amendments on the floor of the house and in the Appropriations Committee to restore any cuts that were made by Governor Parkinson.

He voted to increase funding on the house floor that would have protected our schools from any consolidation issues and voiced his deep concerns about the post audit study that would have mandated consolidation in rural Kansas. He voted for a 0.4 percent sales tax that would have restored any cuts that had been made by the governor to K-12 education. He did not vote for the 1 cent sales tax, an 18.9 percent hike in sales tax because "it would have been a larger tax than was necessary to do the job.

He supported amendments to restore and add to the funding for DSNWK, LINK and many other programs. "If we don't protect the most vulnerable citizens in our state, then we have not done a very good job as legislators,' Faber stated.

Based on Federal requirements, Faber remarked that "the State of Kansas will be redrawing all district boundaries prior to the 2012 elections. Over the last 14 years I have watched the migration of families from western Kansas to the eastern part of the state. I intend to use my seniority - only 17 out of 125 State Representatives has served longer - to make sure the 120st district is wellserved."

"Finally, I want to use my passion for rural Kansas and the importance of technology to work with the new governor and their administration. We need to have a seat at the table' when important decisions are made."

John Faber, has served under three Governors: Bill Graves, Kathleen Sebelius and Mark Parkinson.

A new governor will be sworn in Jan. 10, 2011; the same day Faber expects to begin his next session. Faber has a 100 percent voting record for pro-life issues over the past 14 years. He started his first campaign in 1996 by promising the pro-life community that he would always be there for them and has kept his commitment.

"It will be a goal of mine and a pleasure that I have looked forward to for 14 years, to serve with a pro-life governor," Faber

When asked his plans, Faber replied, "My focus has always been in two areas . . . my family and my service to others. At age 57, with the support of my family, I am starting this campaign. If the voters in the 120th district like the work I've done for the last 14 years, I will be back in Topeka in January," he said.


