# THEY DIED SO WE CAN BE FREE A Special Tribute to Michael Donovan

## Missing airman had family waiting at home

This is the third in a four-part series about servicemen killed in the line of duty.

The United States Air Force officially declared, Capt. Michael L. Donovan, Norton, dead in 1974, three years after the plane he was piloting failed to return from an operational mission over Laos. He had been listed as Missing in Action (MIA) since Sept. 30, 1971. Flying with Capt. Donovan was his navigator, Ron Bond. The announcement ended almost three years of uncertainty for his widow, Tamra, his two children, Michele, 11, and Todd, 3, and his parents, Mr. and Mrs. B.J. Donovan, all of Norton.



# City, business owner spar over burst pipe's aftermath

Strong words and feelings were expressed at the regular meeting of the Norton City Council on Wednesday, Sept. 15. Richard Stull, owner and operator of the McDonald's in Norton, was present and he stated the City had undertaken the task of being a municipal water and electric supplier and is obligated to provide clean, consistent and dependable power and water. He presented the council with an estimate of his incurred costs as the result of the water main break that occurred on Friday.

Jeff Otter stated, "You can play the

victim, but the break was a natural disaster and the City will not reimburse for a natural disaster." Otter further stated, "We had a 12 inch main rupture and unless the City gets funds from FEMA or other financial aid, the City would not reimburse anyone."

"You can be a hero or a heel." said Jeff Otter in response to Mr. Stull's statement that this was not a natural disaster.

"If you want to get personal, Jeff, this was not a natural disaster or an act of God," said Stull. Stull said that the City has a responsibility to provide the capital outlay to maintain and upgrade their facilities, including their distribution
