Cause of the fire has not been determined.

Thirteen firemen and three fire units from the Norton City Fire Department were dispatched to 303 E. Lincoln at 7:14 a.m. Tuesday, Nov. 23 after a report of a fire at the northwest corner of the building, said Kirk Nuzum, assistant fire chief.

Nuzum said the Norton City Police Department assisted at the scene with dispatching and directions. The Norton County EMS was placed on standby.

"By the time we got there, all the people were out. We were advised it was empty," he said.

Firemen knocked down an exterior wall of the home and entered from the front. Three firemen entered with air-packs with three firemen also with air-packs backing them up.

The fire did extensive damage to the northwest corner of the building, he said.

Nuzum said firemen could hear smoke alarms going off inside the building. He said it's a good reminder to people to make sure they have working smoke alarms.

He thanked the Norton Police Department for their help at the scene as well as the Norton city electric crew for getting to the scene and getting the electricity to the building shut off quickly.

### Norton Cares fills residents' need for transportation

salon, 90 percent of the requests are to drive people to out-of-town medical appointments.

The service operates with money from donations, memorials and fundraisers. The most recent fundraiser was a potato bar at the Senior Center last week.

The organization averages 20 medical trips a month to Hays or Kearney. Though they have taken passengers to Salina, Wichita and North Platt, the majority of the trips are to Hays and Kearney.

Approximately 50 people a month use the service. In addition to their other trips, volunteers go shopping for the Andbe Home residents once a week.

Some weeks several of the residents need items, other weeks few do.

Patrons of the service can be all ages. However, children need to be accompanied with an adult.

"We have taken a parent and child to a dental appointment," Pabian said.

Three people currently require rides on a regular basis. Of those, one person goes to Hays three times a week for dialysis. A second person will be riding three times a week after the New Year.

There are no income guidelines.

"It's a free service to any person who needs it," Matzek said.

Drivers get paid for their mileage, and must drive their own vehicles. However, the service does have access to a privately owned handicapped accessible vehicle when needed.

Anyone needing assistance can call volunteers to drive her. 877-2131.
