## December tax, tag deadlines loom

December 20th is the deadline for the 1st half taxes of 2010 to be paid at the Norton County Treasurer’s Office without a penalty. Remember to bring or send your stubs from your tax statements to ensure proper credit to your account. You may also pay your taxes online at [www.kansas.gov/propertytax](http://www.kansas.gov/propertytax). You need your name id and statement number from each tax statement you wish to pay. The deadline for persons whose last name begins with or business name begins with “U”, “X”, “Y” or “Z” to renew automobile, light trucks, motorcycles or motorbikes will be Thursday, December 30th.

When renewing your vehicles, remember to include your current proof of insurance for all vehicles. We need to verify the VIN number, policy number and current expiration date. The treasurer’s office will be closed Friday, December 24th and Friday, December 31st for the Holiday season. Driver license renewals can be done Tuesday through Friday from 8 a.m. to 4 p.m. You need to have your driver license, social security card or something with your number on it and a utility bill with name and address. CDL licenses can be renewed at a full service office in Phillipsburg, Hays
