## Pantry gives comfort to hundreds

God's Pantry is a volunteer-run community food distribution center operating under the umbrella of Norton's Trinity Episcopal Church.

Pantry director, Connie Johnson, said 245 families have already been served this year which is 33 more than was served in all of 2009. Mrs. Johnson said the need is great but, the Norton community has always been supportive of the pantry's work.

Begun in 1985 under the leadership of Dr. Bob Long and Abe Schneider, the goal of God's Pantry was to give food, on an emergency basis, to anyone in Norton County. The program operates year-round out of a building on the south side of the church located at 102 E. Waverly. The pantry is open Sundays from 3 to 4 p.m.

Mrs. Johnson said the pantry is not a grocery store and families are limited to using the pantry three times in a six month period for a total of six times a year. However, families are allowed to choose the food they want from the supply on hand. No one is forced to take foods they know their family won't eat.

In addition to accepting canned goods, God's Pantry volunteers welcome the donation of cash which they use to buy staples from local groceries and discount stores. Other non-food items needed include disposable diapers, toothpaste, deodorant, shampoo and conditioner, band-aids, laundry detergent, paper towels, toilet paper and personal hygiene products. Donated items may be left at The Norton Telegram office and Pamida.

After discussing the matter, the commissioners asked County Attorney Doug Sebelius for advice. Mr. Sebelius said that the commissioners should warn land owners not to take any of millings or it could be construed as stealing.

The regular meeting of the Norton City Council was held Wednesday, Dec. 15 where two public hearings were scheduled. In the absence of Mayor Corns, Council President Jeff Otter presided over the meeting.

Otter, called the Public Hearing for the amended budget hearing to order at 5:35 p.m. The proposed amendments will increase the Airport Bond and Interest Fund from \$36,510 to \$39,438 and the Tourism Fund from \$21,000 to \$25,128. There were no comments from the public and the hearing was closed at 5:37 p.m. The amendments to the budget were published in The Norton Telegram on Dec. 3, 2010. The council approved to accept the 2010 budget amendments.

The retirement reception for Vance Poage will be held on Dec. 23 from 2 to 4 p.m. at the City Office. Vance has been an employee of the City for 24 years.

The position of Wastewater Plant Operator Trainee will be offered to Drew Eagleburger at a starting pay rate of 4-A.

The Norton County commissioners decided not to buy a new road grader, a major purchase which they had been discussing for some time, after talking to Road and Bridge things," Smith replied. Administrative Assistant Sandy Smith during their meeting a week ago Monday.
