Dispatch changes coming

By CYNTHIA HAYNES c.haynes@nwkansas.com Norton County Sheriff Troy Thomson doesn't want to keep up with the Jones or the Johnson counties but he may have to.

The sheriff's office has received an \$89,000 grant for computer-aided dispatch equipment and services from the State of Kansas Governor's Grant Program.

The money will be used to keep track of where his people are going and what they're doing, he said, and should help eliminate hand logs.

Besides computer equipment for better tracking the money will pay the \$13,000 annual county 911 maintenance fee and the \$1,200 monthly 911 trunk fees, Sheriff Thomson told the Norton County Commissioners on Monday.

While the information will be useful, the changes will be tough on the office staff, the sheriff said. Right now, the county dispatchers help out with clerical, typing and filing, helping out in the jail

County purchases new grader for roads

After weeks of discussion and checking prices and products, the Norton County commissioners agreed during their yearend meeting that they would purchase a new dozer for the Road and Bridge Department.

Since the purchase is a major one, the commissioners said they wanted to get the best deal they could.

They got bids from Murphy Tractor in North Platte on a 2008 John Deere and from Foley Equipment out of Colby on a 2005 CAT.

Road crew employees were asked to check out a similar model CAT that Decatur County owns and commissioners asked about extended maintenance agreements and the cost of getting the giant machine to Norton County.

On Thursday, at their end-of-the-year meeting, the commissioners agreed that the John Deere grader would be a better deal since it was not only newer than the CAT model but the bid was more than

\$10,000 less. The John Deere will cost \$68,803.

The CAT was bid at \$78,000, commissioners said.

The commissioners agreed to put \$20,000 down on the machine and pay the rest on a lease purchase agreement over five years.

The dozer, which the new machine is replacing, was not in good enough shape for the bidders to take it as a trade in so Sandy Smith, who has been acting as liasion between the commissioners and the road and bridge department, asked if it should be put out on bids or just scrapped.

The commissioners decided to put the machine out for bids.

In other business, the commissioners: • Heard that Roger Braun took 23 loads of millings although he was owed 24. He said that his truck was a little big so he felt that was fair, Commissioner John Miller said. He was satisfied and so is the county Smith said. The county crews will restore the land and put a fence back up, the commissioners said.
