# Disaster deadline is approaching

The deadlines for the United been approved and production Farm Service Agency to accept must file an Application for Pay-State Farm Service Agency Committee. The application closing date of March 15th applies to the following crops: Sorghum Cane, vegetable and melon crops plus, Amaranth, Chestnuts, Cotton, Pecans, Pumpkins, Safflower, Sesame, Squash, and Walnuts.

Crops eligible for Noninsured Assistance Program benefits are limited to those not insurable in the county and are produced for food or fiber. Included as eligible crops are Sorghum Cane (for forage and graze), floricultural, ornamental nursery, Christmas trees, turf grass sod, industrial crops, seed crops, aquaculture (including ornamental fish),

Interested producers who may wish to participate in the Noninsured Assistance Program program must visit their local Farm Service Agency office to complete an Application for Coverage (Form CCC-471) and pay the applicable service fee by the type and variety, and it must be applicable sales closing date for the specific crop. Administrative service fees are collected in order to help offset the cost of implementing the program and range from \$250 per crop per administrative county not to exceed \$750 per producer per administrative county with a \$1,875 maximum fee for multi-county producers.

In the unfortunate event that a producer does suffer a loss on their particular crop, a Notice of Loss (Form CCC-576) must be filed with the local Farm Service Agency office within 15 calendar days after the disaster occurrence, or the date the loss becomes apparent to the producer.

Producers are responsible for providing accurate and complete information. This includes timely certifying the unit's planted acreage and production with Farm Service Agencies. In general, acreage reporting deadlines are June 1st for small grain crops, and the earlier of August 1st or 15 days prior to the onset of harvest or grazing for all other crops. Production reporting deadlines are no later than the immediately subsequent crop year acreage reporting date for the crop. It's always important to check with the local Farm Service Agency office to determine what the acreage and or production reporting deadlines are for each specific crop.

When required, producers shall provide to Farm Service Agency verifiable or reliable production evidence for the crop by practice, provided in a manner that can be easily understood. Producers shall maintain their production evidence for 3 years after the crop year it is initially certified.

This coverage entitles eligible producers to a payment of 55 percent of an average market price for the commodity if a natural disaster caused a 50 percent production loss or greater of an eligible crop.

Producers are limited to \$100,000 in benefits per person per crop year, they must not exceed the \$2 million gross revenue provisions, and they must comply with conservation compliance provisions in order to be deter-

department (public health) do anyway? How long has there been a Medicare Certified home health agency in the county? These are both good and often heard questions posed to our department. Our hope is that these and many more questions will be answered by the time readers finish this article about the Norton County Health Department and PRN

Home Health Agency. Let's take a big picture view of public health before delving into the details of Norton County Health Department. How public health is provided in this nation varies from state-to-state and even from county to county. For Kansas this means that each county has its own local health department. About 25 other states operate in this same fashion. Norton County's creation of public health started when Lila Atwell, B.S.N. was hired as a "county health nurse" in 1975. Her office was in the basement of the Norton County Hospital. In 1977 a Medicare certified home health agency was added. This was actually done as a multi-county effort including Phillips, Rooks and Norton counties - joining together to form an agency with the name PRN Home Health Agency. This multi-county agency was eventually dissolved a few years later, but Norton retained the original agency name. As more staff and programs were added, the Norton County Health Department and home health agency moved to its present location at 801 N. Norton. This location went through a major renovation in 1997 (paid Department's savings) and an

Norton County Health Department has a minimum of 9 grants that are renewed annually generating over \$110,000. Some of these grants provide the following programs/ services:

> WIC - supplemental food program for women, children and infants residing in Norton and **Decatur Counties**

Family Planning – reduced cost women's health program

Chronic Disease Risk Reduction – promotes a healthy lifestyle by focusing on increasing both the amount of physical activity and consumption of fruits and veggies as well as prevention of tobacco use and/or helping people quit in Norton County

Healthy Start Home Visitor – home visiting program to any recently delivered baby and their mom in Norton County to provide information on resources and health education

Unfortunately, many of the duties and obligations of public health are not funded. One ex-

ample is: Disease surveillance and investigation – tracking 65+ diseases that are by law to be reported to public health so we can rapidly respond to investigate those ill, minimize spread, assist primary care providers and prevent reoccurrence if possible through education and/or vaccination. Some of these diseases includes, but isn't limited to Tuberculosis, salmonella, e. coli, hepatitis C

weekly medication box management. Physical therapy is also an in-home service. We accept payment from Kansas Medicaid, Blue Cross Blue Shield of Kansas, Area Agency on Aging and cash for services not covered by one of the fore mentioned. With this diversity of pay sources, most people will find an option that they qualify for and/or fits their budget. Besides the nurse level services, we have certified home health aides that assist patients with activities of daily living. Bathing, housekeeping, meal preparation, errands, blood pressure checks and foot care are some of the services provided to help our citizens remain safely in their home.

So what is the value of having the Norton County Health Department and PRN Home Health Agency to you? Because public health is focused on preventing people from getting sick and promoting healthy living the value of our department is often underestimated.

Did you know that for every dollar spent on a childhood immunization \$27 is saved? In 2009, Norton County Health Department vaccinated 3,148 people with 5,269 vaccines. These vaccines prevent sickness, disability and death. This means children stay healthy, parents go to work, and kids stay in school and those in the community with weakened immune systems aren't exposed to the diseases vaccines prevent. Parents in other parts of this world still have to watch their children suffer and even die to diseases we in America seldom even witness due to the effectiveness and availability of vaccines.

Our Family Planning program serves on average 90 clients. About ½ of these clients do not have health insurance. Without this program women would go without birth control, preventative screenings such as a PAP smear have both seen dramatic changes means for those that qualify, home and an annual physical.

County. We know for every \$1 we spend managing this program it is a \$7 return to the community. In 2009, Norton County grocery stores took in \$91,634 of WIC checks and Decatur had \$28,151. This doesn't include all the non-WIC food purchases and shopping

done by WIC participants. Our home health agency keeps clients where we all prefer to be when we are aging or ill.....at home. The rising cost of acute and long term care makes staying at home with adequate support from a multi-service agency like PRN Home Health Agency not only a preference, but a cost saving one as well for the patient and society as a whole.

Your Norton County Health Department and PRN Home Health Agency does all these things and much more utilizing only \$64,000 of local tax support. This is only 13-15% of the department's annual revenue. This means we not only provide a diverse array of services/programs to meet your needs, but we do so with very little of your tax dollars.
