Norton City Council continues clean up job

In its continuing effort to clean up the town, the Norton City Council passed four resolutions Wednesday night aimed at enforcing ordinances dealing with nuisance property.

The resolutions all pertain to property at 507, 509 and 511 N. Graves owned by Kevin Wilt-

The first resolution deals with maintenance on the properties. It requires that the building and grounds be maintained in a clean and neat appearance and pest free. The owner is given 60 days to comply.

The second resolution deals with health hazards. It requires that all trash, stagnant water and abandoned appliances be removed. The owner has 45 days to comply.

The third resolution is for environmental hazards and requires all abandoned vehicles, lumber, concrete, tires, bikes and lawnmowers be removed and that exterior structures, including fences, and walls be maintained. The owner has 45 days to comply with most of the resolution but 60 days on the exterior items.

The fourth resolution is for weeds and the owner has 45 days to clean up the excess vegeta-

The council agreed to a new

Library System on the property it now uses.

The former lease, which has expired, was for 20 years, Councilman Jeff Otter told the group. The new lease, which is for a little more money, will be for 10 years. The library system has agreed to pay \$2 per sq. ft. per year for the space. That would provide the city with \$12,204 a year, Mr. Otter said.

Mr. Otter also mentioned that the finance committee came up with more than \$65,000 in material costs the city has provided for business expansion on such projects as the new motel, hospital expansion, courthouse renovation. This does not include either labor or use of vehicles, he said, but shows that the city by serious about providing businesses with incentives to expand or settle in

Councilwoman Donna Foley said that the Public Safety Committee is looking at getting a stop sign for the corner of Pearl and Case streets. The intersection is a T, she said, and ends right at the state Department of Transportation shops. Because of a dip in the pavement, there have been some problems with vehicles running into the state's fence.

City Administrator Rob Lawson reported on the Airport Board meeting he attended.

The airport has received a \$202,275 federal grant, he said, to install a visual guidance system, lease with the Northwest Kansas a lighted wind cone, precision the Winners Circle on Oct. 29.

The grant will be paid 95 percent by the federal government. The remaining 5 percent will be split between the city and the

This is a great opportunity to upgrade the airport, he said.


