County considers landfill expansion

Brian Foster of BG Consultants met

with the Norton County Commissioners on June 30 to explain that the solid waste management facility for Norton County is nearing capacity, but an additional 200 feet of space is ready to be prepared for use.

City approves water plant renovation bid

cbell@nwkansas.com The Norton City Council awarded a bid Wednesday evening for the completion of the second phase of improvements at the city's water system/wastewater treatment facility.

Chris Miller of Miller and Associates reported to the council Wednesday evening that three contractors submitted bids for the project with the lowest bid coming in from Walter-Morgan of Manhattan. The company's base bid came in at \$1,576,000, which Miller reported leaves just under \$40,000 for contingency funds in case of budget over-runs. Though the project came in under budget, it will still be more costly than the original

estimates, a trend that Miller attributes to rising prices of copper and equipment for the facility.

Norton City Administrator Rob Lawson explained that the latest water distribution facility renovation is the final phase of a 15-year project to bring the plant into compliance with state environmental regulations. The final phase will include tying up loose ends from the first two phases of the project, including a service elevator replacement, fiberglass covers over the clarifier tanks, roof construction over the bulk chemical tanks, valve and piping replacement and the installation of a backup generator system.

After deciding to renovate the former Doctors Clinic building for Colby Community College, Norton County Hospital officials reported recently that the cost of the renovation has been estimated at just over \$350.000.

Hospital Administrator Rich Miller reported to the Norton County Board of Commissioners Thursday morning that hospital officials solicited bids for the renovation of the former Doctors Clinic to be able to house the Colby Community College Norton Campus. While the facility will house all of the campus programs, the primary purpose will be a home for the school's nursing program.

Miller reported that the bid opening was held last Tuesday and three companies submitted bids for the project. "We had three contractors show up to the pre-bid conference in June," Miller said. "Those same three contractors submitted bids, which doesn't always happen, but in this case, all three went ahead with the

bidding process."

Though all three companies submitted similar bids, the lowest bidder was Deines Construction with a base bid of \$353,000. Deines Construction is based in Trego County.

Along with the base bid, hospital officials solicited some alternate bids that could include some optional projects, like parking lot expansion.

Now that the bids have been received and the cost of the project is more predictable, hospital leaders are working with Norton County Economic Development to secure financing for the project. Prior to receiving bids, Director Scott Sproul explained that the details of financing haven't yet been hammered out, but that he and hospital leaders would be actively seeking potential funding sources for the project.

Construction is expected to begin later this summer for the renovation and Miller reported in late June that the renovation could be finished as soon as February, though April is a more likely estimate.



The former Doctors Medical Clinic is slated to be renovated this winter and open next spring as the Colby Community College Norton Campus to house the school's Nursing program.
