Caylee's Law could be reality

"Our job at SRS is to protect children in Kansas. There's no reason a child's disappearance should go unreported," Siedlecki said. "I appreciate Speaker O'Neal's work to review our laws regarding the issue in Kansas, and his plans to address the situation the next legislative session."

"I appreciate Secretary Siedlecki's dedication to protecting children and I look forward to working with him as we draft tougher

penalties for failing to report the disappearance of a child," Speaker O'Neal said.

Efforts to draft a "Caylee's Law" are already underway in Oklahoma, Maryland, Florida, North Carolina, Kentucky, Pennsylvania and New Jersey. According to Speaker O'Neal, Kansas presently does not appear to impose adequate criminal penalties for failure to notify law enforcement of the death or disappearance of a child.
