Norton had won three out of four games with Smith Center this season but the Blue Devils made the Blue Jays work for every run they got.

In the early game, No.1 seeded Colby defeated No. 4 seeded Goodland 8-5.

In Wednesday's loser's bracket, Goodland outscored Osborne 18-5 and Smith Center defeated Trego 14-5.

Goodland played Smith Center and

Norton scored one run in the top of the first inning but Smith Center tallied four in the bottom of the first. Two more Smith Center runs in the bottom of the second gave them a 6-1 lead. Norton made it 6-3 in the top of the third and tied it at 6-all in the top of the fourth.

Smith Center took a 7-6 lead in the bottom of the fourth. Two Norton runs in the top of the fifth made it 8-7 in favor of Norton and four more Blue Jay runs in the top of the sixth extended Norton's lead

scored four more runs in the bottom of the sixth to cut the Norton lead to 12-11.

The Blue Jays got two insurance runs in the top of the seventh inning and held the Blue Devils scoreless in the bottom of the seventh to earn the 14-11 victory and keep moving in the winners' bracket.

Norton's single run in the top of the first inning came when Brett Terrell walked and Dalton Miller singled him home.

Terrell got on base on an error in the top of the third, Trey Millan was hit by a pitch and advanced, Spencer Shirk and Kaid McKenna both singled and Terrell and Millan both scored.

Norton's three runs in the top of the fourth stanza to tie the score at 6-all were scored when Troy Bainter and Chris Maddy both singled, Terrell walked, Shirk singled and all but Shirk scored.

The Blue Jays' two more runs in the top of the fifth to put Norton ahead 8-7 came when Tug Keiswetter and Dakota Dreher both singled, Bainter got on base on an error and Keiswetter and Dreher crossed home plate.

The Blue Jays got four runs on four hits in the top of the sixth to make it 12-7. Shirk and McKenna both singled, Keiswetter was hit by a pitch and advanced, and Dreher and Bainter both singled. All except Bainter scored.

Smith Center's four runs in the bottom of the sixth narrowed the Norton lead to 12-11 but the Blue Jays ran two runs across in the top of the seventh when Miller singled, Shirk and Dreher walked and Bainter singled. Miller and Shirk both scored.

Norton's bats were very active. The Blue Jays had 14 hits, ten walks and eight strike outs.

Leading hitters were Spencer Shirk and Troy Bainter, both of whom were 3 for 4 with the bat. Dakota Dreher was 2 for 4 at the plate.

Spencer Shirk started on the mound for Norton and was relieved in the bottom of the fifth by Tug Keiswetter.

Smith Center had 11 hits, three walks and 12 strike outs.
